## AN ACT

- Designating West Erie Avenue from its intersection with North Second Street in Philadelphia City, Philadelphia County, to
- the point where it meets North Front Street in Philadelphia
- 4 City, Philadelphia County, as Roberto Clemente Way.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Roberto Clemente Way.
- 8 (a) Findings. -- The General Assembly finds and declares as
- 9 follows:
- 10 (1) Roberto Walker Clemente was born in Barrio San Anton
- in Carolina, Puerto Rico, on August 18, 1934.
- 12 (2) Roberto Clemente is remembered today as one of
- 13 baseball's best all-round right fielders, with one of the
- 14 best arms in baseball. Often referred to as "The Great One,"
- 15 Clemente was the first Latin American player elected to the
- 16 Baseball Hall of Fame.
- 17 (3) Roberto Clemente's life ended on December 31, 1972,

- in a plane crash while en route to Nicaragua with relief
- 2 supplies for earthquake victims.
- 3 (4) In his thirty-eight years, Roberto Clemente became a
- 4 baseball legend in the United States, but in his homeland and
- 5 throughout Latin America he became a national and cultural
- 6 icon. For his "outstanding athletic, civic, charitable, and
- 7 humanitarian contributions," Roberto Clemente was awarded the
- 8 Congressional Gold Medal by the United States Congress in
- 9 1973.
- 10 (b) Designation. -- West Erie Avenue from its intersection
- 11 with North Second Street in Philadelphia City, Philadelphia
- 12 County, to the point where it meets North Front Street in
- 13 Philadelphia City, Philadelphia County, is designated as Roberto
- 14 Clemente Way.
- 15 (c) Signs. -- The Department of Transportation shall erect and
- 16 maintain appropriate signs displaying the name of the highway to
- 17 traffic in both directions.
- 18 Section 2. Effective date.
- 19 This act shall take effect immediately.
