AN ACT

- 1 Providing for enforceability of certain indemnity provisions in snow removal and ice control services contracts.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Short title.
- 6 This act shall be known and may be cited as the Commercial
- 7 Property Snow Removal Service Liability Limitation Act.
- 8 Section 2. Definitions.
- 9 The following words and phrases when used in this act shall
- 10 have the meanings given to them in this section unless the
- 11 context clearly indicates otherwise:
- 12 "Commercial property." A property or portion of a property
- 13 that is used, occupied or is intended, arranged or designed to
- 14 be used or occupied for the purpose of operating a business, an
- 15 office, a manufacturing facility or a public accommodation. The
- 16 term includes any of the following:
- 17 (1) All or part of a building, structure or facility on
- the property or portion of the property.

- 1 (2) A residential development operating under a
- 2 homeowners' association for the maintenance of the property
- 3 or portion of the property.
- 4 (3) An apartment complex consisting of five or more
- 5 residential dwelling units.
- 6 "Person." Includes a corporation, partnership, limited
- 7 liability company, business trust, other association, estate,
- 8 trust, foundation or individual. The term does not include the
- 9 Commonwealth, a political subdivision or an instrumentality of
- 10 the Commonwealth or a political subdivision.
- "Political subdivision." A county, city, borough,
- 12 incorporated town, township, school district, vocational school
- 13 district or county institution district.
- "Service provider." A person providing services for a
- 15 commercial property under a snow removal and ice control
- 16 services contract.
- 17 "Service receiver." A person receiving services for a
- 18 commercial property under a snow removal and ice control
- 19 services contract.
- "Snow removal and ice control services contract." A contract
- 21 or agreement for the performance of any of the following:
- 22 (1) Plowing, shoveling, relocating or other removal of
- snow or other mixed precipitation from a surface.
- 24 (2) De-icing services.
- 25 (3) A service incidental to an activity under paragraph
- 26 (1) or (2), including operating or otherwise moving snow
- 27 removal or de-icing equipment or materials.
- 28 Section 3. Certain indemnity agreements void.
- 29 A provision, clause, covenant or agreement that is part of or
- 30 in connection with a snow removal and ice control services

- 1 contract is against public policy and void if it requires, or
- 2 has the effect of requiring, a service provider to:
- 3 (1) indemnify a service receiver for damages resulting
- 4 from the acts or omissions of the service receiver or the
- 5 service receiver's agents or employees; or
- 6 (2) defend a service receiver against any tort liability
- 7 for damages resulting from the acts or omissions of the
- 8 service receiver or the service receiver's agents or
- 9 employees.
- 10 Section 4. Applicability.
- 11 The following shall apply:
- 12 (1) This act shall apply to snow removal and ice control
- services contracts entered into on or after the effective
- 14 date of this act.
- 15 (2) This act shall not apply to an insurance policy, a
- surety bond or workers' compensation.
- 17 (3) This act shall not affect any immunities or
- 18 affirmative defenses arising under other law.
- 19 Section 5. Effective date.
- This act shall take effect immediately.
