## AN ACT

10	Section 1. Section 3 of the act of November 22, 1978
11	(P.L.1166, No.274), referred to as the Pennsylvania Commission
12	on Crime and Delinquency Law, is amended by adding a paragraph

14	Section 3. Powers and duties of the commission.
15	The commission shall have the power and its duty shall be:

17	(19) To offer and cause to be paid rewards of up to
18	\$50,000 for information leading to the arrest and conviction
19	<u>of perpetrators of an offense under 18 Pa.C.S. § 2507</u>
20	(relating to criminal homicide of law enforcement officer)

1	Section 2. The act is amended by adding a section to read:
2	Section 8.2. Constable William Davidson Reward Fund.
3	(a) Establishment of fundThe Constable William Davidson
4	Reward Fund is established as a special fund in the State
5	<u>Treasury.</u>
6	(b) AdministrationThe fund shall be administered by the
7	commission. The commission shall use money in the fund solely
8	for the purpose of section 3(19).
9	(c) Fund sourcesThe sources of the fund are as follows:
10	(1) Money transferred under subsection (d).
11	(2) Contributions and donations to the fund.
12	(d) TransfersCommencing with fiscal year 2018-2019 and
13	continuing annually thereafter, the sum of \$750,000 shall be
14	transferred from the State Gaming Fund to the Constable William
15	Davidson Reward Fund.
16	(e) DefinitionAs used in this section, the term "fund"
17	means the Constable William Davidson Reward Fund.
18	Section 3. This act shall take effect in 60 days.
