AN ACT

- Amending Title 75 (Vehicles) of the Pennsylvania Consolidated 1 Statutes, in registration of vehicles, further providing for 2
- special motorcycle plates related to veterans and for special 3
- plates for veterans. 4
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Sections 1361 and 1364 of Title 75 of the
- Pennsylvania Consolidated Statutes are amended to read: 8
- 9 § 1361. Special motorcycle plates related to veterans.
- 10 (a) [Honorably discharged veterans. -- Upon application of any
- person who is an honorably discharged veteran of the armed 11
- 12 forces of the United States, or a reserve component of the armed
- 13 forces as defined in 51 Pa.C.S. § 7301 (relating to
- 14 definitions), accompanied by a fee of \$20] Veterans. -- Upon
- application of any person who is a veteran as defined under 51 15
- 16 Pa.C.S. § 7101.2 (relating to definitions), accompanied by a fee
- 17 of \$26 which shall be in addition to the annual registration fee
- and by such documentation as the department shall require, the 18

- 1 department shall issue to the person a special registration
- 2 plate designating the vehicle as belonging to a person who is a
- 3 veteran. The special registration plate may be used only on a
- 4 motorcycle.
- 5 (a.1) Women veterans.--Upon application of any woman who is
- 6 <u>a veteran as defined under 51 Pa.C.S. § 7101.2, accompanied by a</u>
- 7 fee of \$26 which shall be in addition to the annual registration
- 8 fee and by such documentation as the department shall require,
- 9 the department shall issue to the person a special registration
- 10 plate designating the vehicle as belonging to a person who is a
- 11 woman veteran. The special registration plate may be used only
- 12 <u>on a motorcycle.</u>
- 13 (b) Honoring our veterans. -- Upon application of any person,
- 14 accompanied by a fee of [\$35] \$41 which shall be in addition to
- 15 the annual registration fee and by such documentation as the
- 16 department shall require, the department shall issue to the
- 17 person a special registration plate designating the motorcycle
- 18 as belonging to a person who is honoring veterans of the armed
- 19 forces of the United States. The special registration plate may
- 20 be used only on a motorcycle. The Veterans' Trust Fund shall
- 21 receive \$15 of the fee paid by the applicant for the plate.
- 22 (c) Honoring our women veterans. -- Upon application of any
- 23 person, accompanied by a fee of \$41, which shall be in addition
- 24 to the annual registration fee and by such documentation as the
- 25 <u>department shall require</u>, the department shall issue to the
- 26 person a special registration plate designating the vehicle as
- 27 <u>belonging to a person who is honoring women veterans of the</u>
- 28 <u>armed forces of the United States. The special registration</u>
- 29 plate may be used only on a motorcycle. The Veterans' Trust Fund
- 30 shall receive \$15 of the fee paid by the applicant for the

- 1 plate. The portion of the fee transferred to the Veterans' Trust
- 2 Fund under this subsection shall be used for programs and
- 3 <u>resources that assist women veterans.</u>
- 4 § 1364. Special plates for veterans.
- 5 (a) [Honorably discharged veterans. -- Upon application of any
- 6 person who is an honorably discharged veteran of the armed
- 7 forces of the United States or a reserve component of the armed
- 8 forces as defined in 51 Pa.C.S. § 7301 (relating to
- 9 definitions), accompanied by a fee of \$20] Veterans.--Upon
- 10 application of any person who is a veteran as defined under 51
- 11 Pa.C.S. § 7101.2 (relating to definitions), accompanied by a fee
- 12 of \$26 which shall be in addition to the annual registration fee
- 13 and by such documentation as the department shall require, the
- 14 department shall issue to the person a special registration
- 15 plate designating the vehicle as belonging to a person who is a
- 16 veteran [of the armed forces of the United States]. The special
- 17 registration plate may be used only on a passenger car or truck
- 18 with a registered gross weight of not more than 14,000 pounds.
- 19 (a.1) Women veterans. -- Upon application of any woman who is
- 20 a veteran as defined under 51 Pa.C.S. § 7101.2, accompanied by a
- 21 fee of \$26 which shall be in addition to the annual registration
- 22 fee and by such documentation as the department shall require,
- 23 the department shall issue to the person a special registration
- 24 plate designating the vehicle as belonging to a person who is a
- 25 woman veteran. The special registration plate may be used only
- 26 on a passenger car or truck with a registered gross weight of
- 27 not more than 14,000 pounds.
- 28 (b) Honoring our veterans. -- Upon application of any person,
- 29 accompanied by a fee of [\$35] \$41, which shall be in addition to
- 30 the annual registration fee and by such documentation as the

- 1 department shall require, the department shall issue to the
- 2 person a special registration plate designating the vehicle as
- 3 belonging to a person who is honoring veterans of the armed
- 4 forces of the United States. The special registration plate may
- 5 be used only on a passenger car or truck with a registered gross
- 6 weight of not more than 14,000 pounds. The Veterans' Trust Fund
- 7 shall receive \$15 of the fee paid by the applicant for the
- 8 plate.
- 9 (c) Honoring our women veterans. -- Upon application of any
- 10 person, accompanied by a fee of [\$35] \$41, which shall be in
- 11 addition to the <u>annual</u> registration fee and by such
- 12 documentation as the department shall require, the department
- 13 shall issue to the person a special registration plate
- 14 designating the vehicle as belonging to a person who is honoring
- 15 women veterans of the armed forces of the United States. The
- 16 special registration plate may be used only on a passenger car
- 17 or truck with a registered gross weight of not more than 14,000
- 18 pounds. The Veterans' Trust Fund shall receive \$15 of the fee
- 19 paid by the applicant for the plate. The portion of the fee
- 20 transferred to the Veterans' Trust Fund under this subsection
- 21 shall be used for programs and resources that assist women
- 22 veterans.
- 23 Section 2. This act shall take effect in 120 days.
