1 forces as defined in 51 Pa.C.S. § 7301 (relating to definitions), accompanied by a fee of \$20] Veterans.--Upon 2 3 application of any person who is a veteran as defined under 51 Pa.C.S. § 7101.2 (relating to definitions), accompanied by a fee 4 of \$26 which shall be in addition to the annual registration fee 5 6 and by such documentation as the department shall require, the 7 department shall issue to the person a special registration 8 plate designating the vehicle as belonging to a person who is a 9 veteran. The special registration plate may be used only on a 10 motorcycle.

11 (a.1) Women veterans.--Upon application of any woman who is a veteran as defined under 51 Pa.C.S. § 7101.2, accompanied by a 12 13 fee of \$26 which shall be in addition to the annual registration 14 fee and by such documentation as the department shall require, the department shall issue to the person a special registration 15 16 plate designating the vehicle as belonging to a person who is a 17 woman veteran. The special registration plate may be used only 18 on a motorcycle.

19 Honoring our veterans. -- Upon application of any person, (b) accompanied by a fee of [\$35] <u>\$41</u> which shall be in addition to 20 21 the annual registration fee and by such documentation as the 22 department shall require, the department shall issue to the 23 person a special registration plate designating the motorcycle 24 as belonging to a person who is honoring veterans of the armed 25 forces of the United States. The special registration plate may 26 be used only on a motorcycle. The Veterans' Trust Fund shall 27 receive \$15 of the fee paid by the applicant for the plate. 28 (c) Honoring our women veterans. -- Upon application of any 29 person, accompanied by a fee of \$41, which shall be in addition to the annual registration fee and by such documentation as the 30

department shall require, the department shall issue to the 1 person a special registration plate designating the vehicle as 2 3 belonging to a person who is honoring women veterans of the armed forces of the United States. The special registration 4 plate may be used only on a motorcycle. The Veterans' Trust Fund 5 shall receive \$15 of the fee paid by the applicant for the 6 7 plate. The portion of the fee transferred to the Veterans' Trust 8 Fund under this subsection shall be used for programs and resources that assist women veterans. 9 10 § 1364. Special plates for veterans. 11 [Honorably discharged veterans.--Upon application of any (a) person who is an honorably discharged veteran of the armed 12 13 forces of the United States or a reserve component of the armed 14 forces as defined in 51 Pa.C.S. § 7301 (relating to 15 definitions), accompanied by a fee of \$20] Veterans.--Upon 16 application of any person who is a veteran as defined under 51 17 Pa.C.S. § 7101.2 (relating to definitions), accompanied by a fee\_ of \$26 which shall be in addition to the annual registration fee 18 19 and by such documentation as the department shall require, the 20 department shall issue to the person a special registration 21 plate designating the vehicle as belonging to a person who is a veteran [of the armed forces of the United States]. Honoring our veterans. -- Upon application of any person, 4 (b) accompanied by a fee of [\$35] <u>\$41</u>, which shall be in addition to 5 6 the annual registration fee and by such documentation as the 7 department shall require, the department shall issue to the 8 person a special registration plate designating the vehicle as belonging to a person who is honoring veterans of the armed 9 10 forces of the United States. The special registration plate may be used only on a passenger car or truck with a registered gross 11 weight of not more than 14,000 pounds. The Veterans' Trust Fund 12 shall receive \$15 of the fee paid by the applicant for the 13 14 plate.

15 Honoring our women veterans.--Upon application of any (C) 16 person, accompanied by a fee of [\$35] \$41, which shall be in 17 addition to the <u>annual</u> registration fee and by such 18 documentation as the department shall require, the department 19 shall issue to the person a special registration plate 20 designating the vehicle as belonging to a person who is honoring 21 women veterans of the armed forces of the United States. The special registration plate may be used only on a passenger car 22 23 or truck with a registered gross weight of not more than 14,000 24 pounds. The Veterans' Trust Fund shall receive \$15 of the fee 25 paid by the applicant for the plate. The portion of the fee 26 transferred to the Veterans' Trust Fund under this subsection 27 shall be used for programs and resources that assist women 28 veterans.

UPON APPLICATION OF ANY PERSON WHO IS A RECIPIENT OF THE 11 PRESIDENTIAL SERVICE BADGE, ACCOMPANIED BY A FEE OF [\$20] <u>\$26</u> 12 13 WHICH SHALL BE IN ADDITION TO THE REGISTRATION FEE AND BY SUCH DOCUMENTATION AS THE DEPARTMENT SHALL REQUIRE, THE DEPARTMENT 14 15 SHALL ISSUE TO THE PERSON A SPECIAL REGISTRATION PLATE 16 DESIGNATING THE VEHICLE SO LICENSED AS BELONGING TO A PERSON WHO 17 IS A RECIPIENT OF THE PRESIDENTIAL SERVICE BADGE. SPECIAL PLATES FOR RECIPIENTS OF LEGION OF MERIT. 21 UPON APPLICATION OF ANY PERSON WHO IS A RECIPIENT OF THE LEGION OF MERIT, ACCOMPANIED BY A FEE OF [\$20] <u>\$26</u> WHICH SHALL 22 23 BE IN ADDITION TO THE REGISTRATION FEE AND ANY DOCUMENTATION THE 24 DEPARTMENT REQUIRES, THE DEPARTMENT SHALL ISSUE TO THE PERSON A 25 SPECIAL REGISTRATION PLATE DESIGNATING THE VEHICLE LICENSED AS 26 BELONGING TO A PERSON WHO IS A RECIPIENT OF THE LEGION OF MERIT. 27 THE SPECIAL REGISTRATION PLATE MAY BE USED ONLY ON A PASSENGER 28 CAR OR TRUCK WITH A REGISTERED GROSS WEIGHT OF NOT MORE THAN 29 14,000 POUNDS.

2 UPON APPLICATION OF A PERSON WHO WAS A CITIZEN OF A FOREIGN 3 COUNTRY THAT ALLIED WITH THE UNITED STATES IN A MILITARY 4 CONFLICT AND SERVED IN A MILITARY BRANCH OF THAT FOREIGN COUNTRY 5 DURING THE MILITARY CONFLICT, ACCOMPANIED BY A FEE OF [\$20] <u>\$26</u> 6 WHICH SHALL BE IN ADDITION TO THE REGISTRATION FEE AND BY SUCH 7 DOCUMENTATION AS THE DEPARTMENT SHALL REQUIRE, THE DEPARTMENT 8 SHALL ISSUE TO THE PERSON A SPECIAL REGISTRATION PLATE 9 DESIGNATING THE VEHICLE SO LICENSED AS BELONGING TO A PERSON WHO 10 IS A VETERAN OF A MILITARY BRANCH OF A FOREIGN COUNTRY THAT 11 ALLIED WITH THE UNITED STATES IN A MILITARY CONFLICT. THE 12 SPECIAL REGISTRATION PLATE MAY BE USED ONLY ON A PASSENGER CAR 13 OR TRUCK WITH A REGISTERED GROSS WEIGHT OF NOT MORE THAN 14,000 14 POUNDS.

15 Section 2. This act shall take effect in 120 days.
