1 unexpended, unencumbered prior year funds that were 2 originally appropriated from the General Fund to any 3 executive branch agency which is subject to the policy, 4 supervision and control of the Governor. The Secretary of the 5 Budget may only make the transfer of funds if the transfer 6 will not result in a deficit in any appropriation from which 7 the funds are transferred. No less than 10 days prior to the 8 transfer, the Secretary of the Budget shall send notification 9 of the transfer in writing to the chairperson and the 10 minority chairperson of the Appropriations Committee of the 11 Senate and the chairperson and the minority chairperson of 12 the Appropriations Committee of the House of Representatives.

13 (2) NO LATER THAN 30 DAYS AFTER THE EFFECTIVE DATE OF <--THIS PARAGRAPH, THE SECRETARY OF THE BUDGET SHALL TRANSFER TO 14 15 THE FUND \$10,000,000 OF THE UNEXPENDED, UNENCUMBERED, PRIOR YEAR FUNDS THAT WERE ORIGINALLY APPROPRIATED FROM THE GENERAL 16 17 FUND TO ANY EXECUTIVE BRANCH AGENCY WHICH IS SUBJECT TO THE 18 POLICY, SUPERVISION AND CONTROL OF THE GOVERNOR. THE 19 SECRETARY OF THE BUDGET MAY ONLY MAKE THE TRANSFER OF FUNDS 20 IF THE TRANSFER WILL NOT RESULT IN A DEFICIT IN ANY

21 APPROPRIATION FROM WHICH THE FUNDS ARE TRANSFERRED. NO LESS

22 THAN 10 DAYS PRIOR TO THE TRANSFER, THE SECRETARY OF THE

23 <u>BUDGET SHALL SEND NOTIFICATION OF THE TRANSFER IN WRITING TO</u>

24 THE CHAIRPERSON AND MINORITY CHAIRPERSON OF THE

25 APPROPRIATIONS COMMITTEE OF THE SENATE AND THE CHAIRPERSON

26 AND MINORITY CHAIRPERSON OF THE APPROPRIATIONS COMMITTEE OF

27 <u>THE HOUSE OF REPRESENTATIVES.</u>
