Amending Title 35 (Health and Safety) of the Pennsylvania Consolidated Statutes, in incentives for municipal volunteers of fire companies and nonprofit emergency medical services 3 agencies, establishing the First Responder Loan Forgiveness 4 Program; and making editorial changes. 6 The General Assembly of the Commonwealth of Pennsylvania 7 hereby enacts as follows: 8 Section 1. - 13 The following words and phrases when used in this subchapter
- 14 shall have the meanings given to them in this section unless the
- 15 <u>context clearly indicates otherwise:</u>
- 16 <u>"Active first responder." A member of an emergency medical</u>
- 17 services agency or a member of a volunteer fire company or <--
- 18 <u>volunteer rescue company.</u>
- 19 "Agency." The Pennsylvania Higher Education Assistance
- 20 Agency.
- 21 "Approved institution of higher learning." A degree-granting
- 22 or certificate-granting educational institution, including a
- 23 vocational school, that:
- 24 (1) offers a postsecondary program of education;
- 25 (2) is located in this Commonwealth; and
- 26 (3) is approved by the agency.
- 27 <u>"Approved program of education." A curriculum or course of</u>
- 28 study pursued at an approved institution of higher learning as
- 29 <u>determined by the agency.</u>
- 30 "Emergency medical services agency." An emergency medical <

- 1 service corporation, association or organization which meets all
- 2 <u>of the following:</u>
- 3 (1) Is located in this Commonwealth.
- 4 (2) Is licensed by the Department of Health.
- 5 (3) Is regularly engaged in the provision of emergency
- 6 medical services, including basic life support or advanced
- 7 <u>life support services and advanced life support squads as</u>
- 8 <u>defined in 28 Pa. Code § 1027.1 (relating to general</u>
- 9 provisions) and licensed quick response services. AS DEFINED_ <--
- 10 IN SECTION 8103 (RELATING TO DEFINITIONS).
- "FIRE COMPANY." A VOLUNTEER FIRE COMPANY.
- 12 "Program." The First Responder Loan Forgiveness Program
- 13 <u>established in section 79A42 (relating to First Responder Loan</u>
- 14 <u>Forgiveness Program</u>).
- 15 "Qualified applicant." An active first responder who
- 16 qualifies for loan forgiveness under section 79A43 (relating to
- 17 award of loan forgiveness).
- 18 "Volunteer fire company." A nonprofit chartered corporation, <--
- 19 association or organization located in this Commonwealth which
- 20 provides fire protection or rescue services and which may offer
- 21 other voluntary emergency services within this Commonwealth.
- 22 Voluntary emergency services provided by a volunteer fire
- 23 company may include voluntary ambulance and voluntary rescue
- 24 services. AS DEFINED IN SECTION 7802 (RELATING TO DEFINITIONS). <--
- 25 <u>"Volunteer rescue company." A nonprofit chartered</u>
- 26 corporation, association or organization located in this
- 27 <u>Commonwealth that provides emergency rescue services.</u> AS DEFINED_<--
- 28 IN SECTION 7802.
- 29 § 79A42. First Responder Loan Forgiveness Program.
- 30 (a) Program established. -- The First Responder Loan

- 1 Forgiveness Program is established. The program shall provide
- 2 loan forgiveness awards to qualified applicants in accordance
- 3 with this subchapter. The agency shall administer the program
- 4 <u>for active first responders on a Statewide basis.</u>
- 5 (b) Applicants.--An active first responder who meets MUST <--
- 6 MEET the following criteria may TO apply to the agency for loan <--
- 7 <u>forgiveness under the program THIS SUBCHAPTER:</u> <--

- 8 (1) Is a resident of this Commonwealth.
- 9 (2) Has been an active first responder, as certified in
- 10 accordance with section 79A48 79A47 (relating to
- 11 certification), for a period of at least one year in this
- 12 Commonwealth.
- 13 (3) Has enrolled ENROLLED as a student in an approved <--
- 14 program of education AND COMPLETED A POSTSECONDARY DEGREE OR <--
- 15 CERTIFICATION PROGRAM.
- 16 (4) Provides the approved institution of higher learning <--
- AGENCY with a sworn or official statement by the Office of <--
- 18 the State Fire Commissioner CHIEF OF THE FIRE COMPANY or the <--
- 19 chief or president of the emergency medical services agency,
- 20 attesting that the applicant is a member in good standing of
- 21 the emergency medical services agency, volunteer fire company <--
- or volunteer rescue company.
- 23 § 79A43. Award of loan forgiveness.
- The agency may provide loan forgiveness for an active first
- 25 responder who, in the first year as an active first responder
- 26 following completion of a postsecondary degree or certification
- 27 program and, in each subsequent year, meets all of the following
- 28 criteria:
- 29 (1) Is a recipient of an agency-administered, federally
- 30 insured student loan.

1	(2) Has completed a certificate or degree program at an
2	approved institution of higher learning. The certificate or
3	degree program must be an approved program of education.
4	(3) Is certified as an active first responder, by the
5	Bureau of Emergency Medical Services or the Office of the
6	State Fire Commissioner, CHIEF OR PRESIDENT OF THE EMERGENCY <
7	MEDICAL SERVICES OR CHIEF OF THE FIRE COMPANY, for four
8	consecutive years preceding the date of application.
9	(4) Executes a sworn affidavit, under penalty of
10	perjury, that the individual does not have a delinquent
11	payment owing to any Commonwealth agency.
12	§ 79A44. Amount of awards.
13	(a) Loan forgiveness Agency-administered, federally
14	insured student loans for an approved program of education
15	provided to a qualified applicant may be forgiven by the agency
16	as follows:
17	(1) The agency may forgive a qualified applicant's loan
18	in an amount up to \$16,000.
19	(2) Payment of the award shall be made in accordance
20	with the procedures established by the agency.
21	(3) A qualified applicant may receive loan forgiveness
22	awards as follows:
23	(i) First year of active first responder status
24	following graduation in an amount up to \$4,000, but not
25	exceeding 25% of the original qualifying loans.
26	(ii) Second year of active first responder status
27	following graduation in an amount up to \$4,000, but not
28	exceeding 25% of the original qualifying loans.
29	(iii) Third year of active first responder status
30	following graduation in an amount up to \$8,000, but not

- 1 <u>exceeding 50% of the original qualifying loans.</u>
- 2 (b) Preference. -- The agency may give preference in approving
- 3 loan forgiveness awards under the program to renewal
- 4 <u>applications</u>.
- 5 <u>§ 79A45</u>. Funding.
- 6 The agency may approve loan forgiveness awards only to the
- 7 extent that funds are appropriated by the General Assembly and
- 8 are sufficient to cover administration of the program. In the
- 9 event that funding is insufficient to fully fund administration
- 10 and awards to all qualified applicants, the agency shall prorate

- 13 The agency shall promulgate regulations and adopt policies,
- 14 procedures and forms as are necessary and not inconsistent with
- 15 <u>the provisions of this subchapter.</u>

- 17 (a) General rule. -- A point system establishing the
- 18 requirements for annual certification of active first responders
- 19 shall be developed and implemented by the chief or president of:
- 20 (1) a volunteer fire company;
- 21 (2) a volunteer rescue company; and
- 22 (3) an emergency medical services agency.
- 23 (b) Factors.--The point system shall be used to determine
- 24 whether to certify an individual as an active first responder
- 25 and shall include the following factors:
- 26 (1) The number of emergency calls to which the
- 27 <u>individual responded.</u>
- 28 (2) The individual's level of training and participation
- 29 <u>in formal training OR DRILLS.</u>
- 30 (3) Time spent by the individual on administration and

- 1 <u>support activities</u>, including maintenance of facilities and
- 2 <u>equipment.</u>
- 3 (4) Involvement by the individual in FUNDRAISING AND <--
- 4 <u>other projects that directly benefit the organization's</u>
- 5 <u>financial viability, emergency response or operational</u>
- 6 <u>readiness.</u>

- 8 (a) Application. -- An applicant for certification as an

- 9 active first responder must submit a signed application to the
- 10 chief or president of the volunteer fire company, volunteer
- 11 rescue company or emergency medical services agency that the
- 12 <u>applicant serves</u>.
- 13 (b) Local sign-off.--The chief or president of the volunteer-<--
- 14 fire company or volunteer rescue company and another officer of
- 15 the volunteer fire company or volunteer rescue company, or the
- 16 chief or president of the emergency medical services agency and
- 17 another officer of the emergency medical services agency, shall:
- 18 (1) Sign the application attesting to the individual's
- 19 status as an active first responder.
- 20 (2) Forward the application to the Office of the State <--
- 21 Fire Commissioner or the Department of Health AGENCY for
- final review and processing.

- 24 The agency shall PROMULGATE REGULATIONS AND ESTABLISH RULES
- 25 OR adopt guidelines, including forms, necessary to administer
- 26 this subchapter.
