AN ACT

- Amending the act of September 27, 1961 (P.L.1700, No.699),
 entitled "An act relating to the regulation of the practice
 of pharmacy, including the sales, use and distribution of
 drugs and devices at retail; and amending, revising,
 consolidating and repealing certain laws relating thereto,"
 providing for nonresident pharmacies.

 The General Assembly of the Commonwealth of Pennsylvania
 hereby enacts as follows:
- 9 Section 1. Section 2 of the act of September 27, 1961
- 10 (P.L.1700, No.699), known as the Pharmacy Act, is amended by
- 11 adding a clause to read:
- 12 Section 2. Definitions.--As used in this act:
- 13 * * *
- 14 (19) "Nonresident pharmacy" means any pharmacy located
- 15 <u>outside this Commonwealth which ships, mails or delivers, in any</u>
- 16 manner, legend devices or legend drugs into this Commonwealth
- 17 <u>pursuant to a prescription order.</u>
- 18 Section 2. The act is amended by adding a section to read:

- 1 Section 4.1. Nonresident Pharmacies.--(a) A nonresident
- 2 pharmacy shall register with the board and obtain a certificate
- 3 of registration to conduct a pharmacy in accordance with this
- 4 <u>section</u>. The nonresident pharmacy shall:
- 5 (1) Disclose annually in a report to the board the location,
- 6 names and titles of all principal corporate officers, if
- 7 applicable, and all pharmacists that are dispensing drugs or
- 8 <u>devices to residents of this Commonwealth. A nonresident</u>
- 9 pharmacy shall file an additional report within thirty days
- 10 after any change of office, corporate officer or pharmacist.
- 11 (2) Submit a statement that the nonresident pharmacy
- 12 complies with all lawful directions and requests for information
- 13 from the regulatory or licensing agency of the state in which it
- 14 <u>is licensed as well as complies with all requests for</u>
- 15 <u>information made by the board pursuant to this section.</u>
- 16 (3) Maintain at all times, a valid unexpired license, permit
- 17 or registration to conduct the pharmacy in compliance with the
- 18 laws of the state in which the nonresident pharmacy is located.
- 19 (4) Before receiving a certificate of registration from the
- 20 board, submit a copy of the most recent inspection report
- 21 resulting from an inspection conducted by the regulatory or
- 22 licensing agency of the state in which the nonresident pharmacy
- 23 is located.
- 24 (b) A nonresident pharmacy shall, during its regular hours
- 25 of operation, but not less than six days per week, and for a
- 26 minimum of forty hours per week, provide a toll-free telephone
- 27 number to facilitate communication between patients in this
- 28 Commonwealth and a pharmacist at the nonresident pharmacy who
- 29 has access to the patient's records. The toll-free telephone
- 30 number shall be disclosed on a label affixed to each container

- 1 of drugs dispensed to patients in this Commonwealth.
- 2 (c) A nonresident pharmacy may not engage in the business of
- 3 shipping, mailing or delivering legend devices or legend drugs
- 4 <u>in this Commonwealth unless the nonresident pharmacy has been</u>
- 5 <u>issued a certificate of registration by the board and has paid</u>
- 6 the fee established by the board by regulation for issuance or
- 7 renewal of the certificate of registration. Applications for a
- 8 <u>certificate of registration as a nonresident pharmacy shall be</u>
- 9 made on a form furnished by the board. The board may require the
- 10 information it deems reasonably necessary to carry out the
- 11 purpose of this section.
- 12 (d) The board may deny, revoke or suspend any certificate of
- 13 registration as a nonresident pharmacy for failure to comply
- 14 with any requirement of this section.
- (e) The board may deny, revoke or suspend any certificate of
- 16 registration as a nonresident pharmacy for conduct which causes
- 17 serious bodily or serious psychological injury to a resident of
- 18 this Commonwealth if the board has referred the matter to the
- 19 regulatory or licensing agency in the state in which the
- 20 nonresident pharmacy is located and the regulatory or licensing
- 21 agency fails to:
- 22 (1) Initiate an investigation within forty-five days of
- 23 referral;
- 24 (2) Complete its investigation within one hundred twenty
- 25 days of referral;
- 26 (3) Resolve the referral through formal agreement,
- 27 settlement or decision within one hundred eighty days; or
- 28 (4) Initiate disciplinary proceedings when the proceedings
- 29 are determined to be necessary in the judgment of the regulatory
- 30 or licensing agency in the state in which the nonresident

- 1 pharmacy is located.
- 2 (f) It shall be unlawful for any nonresident pharmacy which
- 3 has not been issued a certificate of registration pursuant to
- 4 this section to advertise its services in this Commonwealth, or
- 5 for any person who is a resident of this Commonwealth to
- 6 advertise the pharmacy services of a nonresident pharmacy which
- 7 has not received a certificate of registration from the board,
- 8 with the knowledge that the advertisement will or is likely to
- 9 induce members of the public in this Commonwealth to use the
- 10 pharmacy for dispensing prescriptions.
- 11 Section 3. This act shall take effect in 60 days.
