## AN ACT

- Amending Title 75 (Vehicles) of the Pennsylvania Consolidated
  Statutes, in registration of vehicles, further providing for antique, classic and collectible plates.

  The General Assembly of the Commonwealth of Pennsylvania
  hereby enacts as follows:
  Section 1. Section 1340 heading, (a) and (b) of Title 75 of the Pennsylvania Consolidated Statutes are amended to read:
- 9 <u>military</u> plates.

10 (a) General rule. -- Upon submission by a vehicle owner of

§ 1340. Antique, classic [and], collectible and antique

- 11 information satisfactory to the department that a motorcycle or
- 12 motor vehicle is an antique motorcycle or motor vehicle or
- 13 classic motorcycle or motor vehicle or collectible motorcycle or
- 14 motor vehicle or antique military motorcycle or motor vehicle,
- 15 accompanied by the appropriate fee, the department may issue
- 16 special plates for the motorcycle or vehicle. The special plate
- 17 for antique motor vehicles, except antique motorcycles and
- 18 <u>antique military motorcycles or motor vehicles</u>, shall bear the

- 1 designation "antique vehicle." The special plate for antique
- 2 military motorcycles or motor vehicles shall be olive drab color
- 3 and bear the designation "antique military vehicle." The
- 4 applicant shall provide photographic proof in a manner specified
- 5 by the department to demonstrate the condition of the motor
- 6 vehicle. No annual registration fee may be charged for antique,
- 7 collectible or classic motorcycles or motor vehicles or antique
- 8 <u>military motorcycles or motor vehicles</u>. A holder of the special
- 9 plates may obtain replacement plates bearing the designation
- 10 "antique vehicle" or "antique military vehicle," as appropriate,
- 11 upon payment of the appropriate fee.

- 13 (b) Use of plates.--It is unlawful for any person to operate
- 14 a motorcycle or vehicle with antique, classic, vintage or
- 15 collectible or antique military registration plates for general
- 16 daily transportation. Permitted use shall be limited to
- 17 participation in club activities, exhibits, tours, parades,
- 18 occasional transportation and similar uses. Occasional
- 19 transportation shall mean no more than one day per week.
- 20 Section 2. This act shall take effect in 60 days.
