AN ACT

- 1 Amending Title TITLES 18 (Crimes and Offenses) AND 42 (JUDICIARY <--
 - AND JUDICIAL PROCEDURE) of the Pennsylvania Consolidated
 - Statutes, in criminal homicide, further providing for the
- 4 offense of causing or aiding suicide; AND, IN DEPOSITIONS AND <--
- 5 WITNESSES, FURTHER PROVIDING FOR DEFINITIONS.
- 6 This act may be referred to as Shawn's Law.
- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 Section 1. Section 2505 of Title 18 of the Pennsylvania
- 10 Consolidated Statutes is amended to read:
- 11 § 2505. Causing or aiding suicide.
- 12 (a) Causing suicide as criminal homicide. -- A person may be
- 13 convicted of criminal homicide for causing another to [commit]
- 14 die by suicide only if he intentionally causes such suicide by
- 15 force, duress or deception.
- 16 (b) Aiding or soliciting suicide as an independent
- 17 offense. -- A person who intentionally aids or solicits another to

- 1 [commit] die by suicide is quilty of a felony of the second
- 2 degree if his conduct causes such suicide or an attempted
- 3 suicide, and otherwise of a misdemeanor of the second degree.
- 4 (c) Sentencing.--
- 5 <u>(1) The Pennsylvania Commission on Sentencing, in</u>
- 6 <u>accordance with 42 Pa.C.S. § 2154 (relating to adoption of</u>
- 7 <u>quidelines for sentencing</u>), shall provide for a sentence
- 8 <u>enhancement within its quidelines for an offense under this</u>
- 9 section when at the time of the offense the person who died
- 10 by suicide or was aided or solicited to die by suicide is
- 11 <u>under 18 years of age or has an intellectual disability or</u>
- 12 <u>autism spectrum disorder.</u>
- 13 (2) As used in this subsection, the following words and
- 14 <u>phrases shall have the meanings given to them in this</u>
- paragraph unless the context clearly indicates otherwise:
- "Autism spectrum disorder." As defined under 42 Pa.C.S.
- 17 § 5992 (relating to definitions), regardless of the age of
- 18 the individual.
- 19 "Intellectual disability." Regardless of the age of the
- individual, significantly subaverage general intellectual
- functioning that is accompanied by significant limitations in
- 22 adaptive functioning in at least two of the following skill
- 23 areas:
- (i) Communication.
- 25 <u>(ii) Self-care.</u>
- 26 (iii) Home living.
- 27 (iv) Social and interpersonal skills.
- 28 <u>(v) Use of community resources.</u>
- 29 (vi) Self-direction.
- 30 (vii) Functional academic skills.

- 2 <u>(ix) Health.</u>
- (x) Safety.
- 4 SECTION 2. THE DEFINITION OF "AUTISM SPECTRUM DISORDER" IN <--
- 5 SECTION 5992 OF TITLE 42 IS AMENDED TO READ:
- 6 § 5992. DEFINITIONS.
- 7 THE FOLLOWING WORDS AND PHRASES WHEN USED IN THIS SUBCHAPTER
- 8 SHALL HAVE THE MEANINGS GIVEN TO THEM IN THIS SECTION UNLESS THE
- 9 CONTEXT CLEARLY INDICATES OTHERWISE:
- 10 "AUTISM SPECTRUM DISORDER." ANY OF THE PERVASIVE
- 11 DEVELOPMENTAL DISORDERS DEFINED BY [THE MOST RECENT EDITION OF]
- 12 THE DIAGNOSTIC AND STATISTICAL MANUAL OF MENTAL DISORDERS
- 13 [(DSM), OR ITS SUCCESSOR], FIFTH EDITION (DSM-5), INCLUDING
- 14 AUTISTIC DISORDER, ASPERGER'S DISORDER AND PERVASIVE
- 15 DEVELOPMENTAL DISORDER NOT OTHERWISE SPECIFIED.
