Amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in abortion, further providing for legislative intent, providing for fetal heartbeat 3 examination, further providing for medical consultation and 4 judgment, for abortion on unborn child of 24 or more weeks gestational age and for reporting. 6 7 The General Assembly of the Commonwealth of Pennsylvania 8 hereby enacts as follows: 9 Section 1. Section 3202(b) of Title 18 of the Pennsylvania 10 Consolidated Statutes is amended by adding a paragraph to read: 11 § 3202. Legislative intent. 12 * * * 13 (b) Conclusions. -- Reliable and convincing evidence has 14 compelled the General Assembly to conclude and the General 15 Assembly does hereby solemnly declare and find that: 16 17 (6) Based on contemporary research, all of the

| 16 | (vi) Cardiac activity begins at a biologically |
| 17 | identifiable moment in time, normally when the fetal |
| 18 | heart is formed in the gestational sac. |
| 19 | (vii) In order to make an informed choice about |
| 20 | whether to continue the pregnancy, a pregnant woman has a |
| 21 | legitimate interest in knowing the likelihood of the |
| 22 | fetus surviving to full-term birth based upon the |
| 23 | presence of cardiac activity. |

| 25 | Section 2. Title 18 is amended by adding a section to read: |
| 26 | § 3203.1. Fetal heartbeat examination. |
| 27 | Before performing an abortion, a physician shall conduct a |
| 28 | physical examination of the pregnant woman and her unborn child |
| 29 | to determine if there is a fetal heartbeat present. The |
| 30 | physician shall utilize the physician's best clinical judgment |

- 2 Section 3. Sections 3204(a), 3211 heading, (a) and (b) (2)
- 3 and 3214(a)(1) of Title 18 are amended to read:
- 4 § 3204. Medical consultation and judgment.
- 5 (a) Abortion prohibited; exceptions. -- No abortion shall be
- 6 performed <u>after a fetal heartbeat is detected</u>. If there is no
- 7 <u>fetal heartbeat</u>, no abortion shall be performed except by a
- 8 physician after either:
- 9 (1) he determines that, in his best clinical judgment,
- 10 the abortion is necessary; or
- 11 (2) he receives what he reasonably believes to be a
- written statement signed by another physician, hereinafter
- called the "referring physician," certifying that in this
- referring physician's best clinical judgment the abortion is
- 15 necessary.

- 17 § 3211. Abortion on unborn child [of 24 or more weeks
- 18 gestational age] <u>after fetal heartbeat is detected</u>.
- 19 (a) Prohibition. -- Except as provided in subsection (b), no
- 20 person shall perform or induce an abortion upon another person
- 21 when the [gestational age of the unborn child is 24 or more
- 22 weeks] unborn child has a detectable fetal heartbeat.
- 23 (b) Exceptions.--

- 25 (2) It shall not be a violation of subsection (a) if the
- abortion is performed by a physician and that physician
- 27 reasonably believes, after [making a determination of the
- gestational age of the unborn child] examining the pregnant
- 29 <u>woman</u> in compliance with section 3210 (relating to
- determination of gestational age), that the unborn child [is

- less than 24 weeks gestational age] does not have a fetal_
- 2 heartbeat.

- 4 § 3214. Reporting.
- 5 (a) General rule. -- For the purpose of promotion of maternal
- 6 health and life by adding to the sum of medical and public
- 7 health knowledge through the compilation of relevant data, and
- 8 to promote the Commonwealth's interest in protection of the
- 9 unborn child, a report of each abortion performed shall be made
- 10 to the department on forms prescribed by it. The report forms
- 11 shall not identify the individual patient by name and shall
- 12 include the following information:
- 13 (1) Identification of the physician who performed the
- abortion, the concurring physician as required by section
- 3211(c)(2) (relating to abortion on unborn child [of 24 or
- more weeks gestational age] <u>after fetal heartbeat is</u>
- 17 <u>detected</u>), the second physician as required by section
- 18 3211(c)(5) and the facility where the abortion was performed
- and of the referring physician, agency or service, if any.

- 21 Section 4. This act shall take effect in 60 days.
