## A JOINT RESOLUTION

- 1 Proposing an amendment to the Constitution of the Commonwealth
- of Pennsylvania, in taxation and finance, further providing
- 3 for appropriations.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby resolves as follows:
- 6 Section 1. The following amendment to the Constitution of
- 7 Pennsylvania is proposed in accordance with Article XI:
- 8 That section 13 of Article VIII be amended to read:
- 9 § 13. Appropriations.
- 10 (a) Operating budget appropriations made by the General
- 11 Assembly shall not exceed the actual and estimated revenues and
- 12 surplus available in the same fiscal year.
- 13 (b) The General Assembly shall adopt a capital budget for
- 14 the ensuing fiscal year.
- 15 (c) Operating budget appropriations shall not be transferred
- 16 <u>out of the General Fund into a special or restricted fund which</u>
- 17 require tax revenue or revenue previously used for General Fund

- 1 <u>expenditures</u>. This subsection shall not apply to the Motor\_
- 2 License Fund or revenue under section 11 of Article VIII.
- 3 (d) Operating budget appropriations may be transferred into
- 4 <u>a special or restricted fund under the following circumstances:</u>
- 5 (1) The money for the fund is collected from a specific
- 6 <u>industry and the appropriations from the fund are used for</u>
- 7 programs related to the specific industry.
- 8 (2) The fund is necessary for the management of retirement
- 9 or other employment benefits offered by the Commonwealth.
- 10 (3) The fund is necessary for management of the
- 11 Commonwealth's lottery system.
- 12 (4) The fund is necessary for the Commonwealth to act as
- 13 trust or trustee for individual residents of the Commonwealth.
- 14 (e) A fund under subsection (d) may not serve a corporate or
- 15 business related purpose.
- 16 Section 2. (a) Upon the first passage by the General
- 17 Assembly of this proposed constitutional amendment, the
- 18 Secretary of the Commonwealth shall proceed immediately to
- 19 comply with the advertising requirements of section 1 of Article
- 20 XI of the Constitution of Pennsylvania and shall transmit the
- 21 required advertisements to two newspapers in every county in
- 22 which such newspapers are published in sufficient time after
- 23 passage of this proposed constitutional amendment.
- 24 (b) Upon the second passage by the General Assembly of this
- 25 proposed constitutional amendment, the Secretary of the
- 26 Commonwealth shall proceed immediately to comply with the
- 27 advertising requirements of section 1 of Article XI of the
- 28 Constitution of Pennsylvania and shall transmit the required
- 29 advertisements to two newspapers in every county in which such
- 30 newspapers are published in sufficient time after passage of

- 1 this proposed constitutional amendment. The Secretary of the
- 2 Commonwealth shall submit this proposed constitutional amendment
- 3 to the qualified electors of this Commonwealth at the first
- 4 primary, general or municipal election which meets the
- 5 requirements of and is in conformance with section 1 of Article
- 6 XI of the Constitution of Pennsylvania and which occurs at least
- 7 three months after the proposed constitutional amendment is
- 8 passed by the General Assembly.
