## AN ACT

- 1 Amending Title 42 (Judiciary and Judicial Procedure) of the
- 2 Pennsylvania Consolidated Statutes, in judicial computer
- system, further providing for utilization of funds in account
- and for surcharge; and repealing annual appropriations
- 5 provisions.
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. Section 3732(a) of Title 42 of the Pennsylvania
- 9 Consolidated Statutes is amended and the section is amended by
- 10 adding a subsection to read:
- 11 § 3732. Utilization of funds in account.
- 12 (a) General rule. -- Except [for the repayments under
- 13 subsection (b) ] as set forth under subsections (b) and (c), all
- 14 moneys deposited into the Judicial Computer System Augmentation
- 15 Account shall be used only for the initial startup and the
- 16 ongoing operations of the Statewide judicial computer system.
- 17 \* \* \*
- 18 (c) Cadet classes. -- Notwithstanding any other provision of
- 19 law to the contrary, all moneys deposited into the Judicial

- 1 Computer System Augmentation Account shall be transferred to the
- 2 Pennsylvania State Police for cadet classes.
- 3 Section 2. Section 3733.1(c) of Title 42 is amended to read:
- 4 § 3733.1. Surcharge.
- 5 \* \* \*
- 6 (c) Allocation and appropriation. --
- 7 (1) The surcharge under subsection (a) (1) shall be
- 8 allocated as follows:
- 9 (i) One dollar shall be deposited into the Access to
- 10 Justice Account.
- 11 (ii) The remainder of money shall be deposited into
- 12 [a separate reserve account within] the Judicial Computer
- 13 System Augmentation Account. [Notwithstanding section
- 14 3732 (relating to utilization of funds in account), money
- deposited under this subparagraph is hereby appropriated
- to the Supreme Court, upon compliance with Article XV of
- 17 the act of April 9, 1929 (P.L.343, No.176), known as The
- 18 Fiscal Code, for the operation of the Judicial
- 19 Department.]
- 20 (2) The fee under subsection (a) (2) shall be deposited
- into the Criminal Justice Enhancement Account.
- 22 Section 3. Section 3734 of Title 42 is repealed:
- 23 [§ 3734. Annual appropriations.
- Beginning with the fiscal year 1987-1988, the General
- 25 Assembly shall appropriate initially from the General Fund and
- 26 thereafter from the Judicial Computer System Augmentation
- 27 Account funds sufficient to meet the costs of the initial
- 28 startup and the ongoing operations of the Statewide judicial
- 29 computer system.]
- 30 Section 4. The amendment, addition or repeal of 42 Pa.C.S.

- 1 §§ 3732(a) and (c), 3733.1(c) and 3734 shall apply to moneys
- 2 deposited into the Judicial Computer System Augmentation Account
- 3 on or after July 1, 2014.
- 4 Section 5. This act shall take effect immediately.
