## AN ACT

1 2 3 4 5 6	Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain provisions applicable as well to private and parochial schools; amending, revising, consolidating and changing the laws relating thereto," in preliminary provisions, providing for information regarding education loans.
7	The General Assembly of the Commonwealth of Pennsylvania
8	hereby enacts as follows:
9	Section 1. The act of March 10, 1949 (P.L.30, No.14), known
10	as the Public School Code of 1949, is amended by adding a
11	section to read:
12	Section 127. Information Regarding Education Loans(a) An
13	institution of higher education that receives Federal education
14	loan information or other student loan information regarding a
15	student enrolled at the institution of higher education shall
16	provide the following to the student on an annual basis prior to <
17	the student's acceptance of the Federal education loan or other
18	student loan disbursed by the institution of higher education:
19	AT A TIME DETERMINED BY THE SCHOOL BUT NO LATER THAN JULY 1 $<$

1 EACH YEAR:

2	(1) An estimate of the total amount of Federal education
3	loans or other student loans which are disbursed by the
4	institution of higher education taken out by the student.
5	(2) Subject to subsection (b), an estimate of the following: <
6	(i) The potential total payoff amount of the Federal
7	education loans or other student loans which are disbursed by
8	the institution of higher education incurred or a range of the <
9	total payoff amount.
10	(ii) Monthly repayment amounts that a similarly situated
11	borrower may incur, including principal and interest, for the
12	amount of the Federal education loans or other student loans
13	which are disbursed by the institution of higher education taken
14	out at the time that the information is provided. BY THE STUDENT <
15	ENROLLED AT THE INSTITUTION OF HIGHER EDUCATION, IF THE LOANS
16	WERE TO GO INTO REPAYMENT AS OF THE DATE OF THE ANNUAL
17	NOTIFICATION UNDER THIS SUBSECTION.
18	(3) The number of years used in determining the potential
19	total payoff amount.
20	(4) Information on how the student can access online
21	repayment calculators.
22	(5) The percentage of the borrowing limit that the student <
23	has reached at the time that the information is provided.
24	(b) The information provided to the student under subsection
25	(a) may include a statement that any estimate or range provided
26	is general in nature and not intended to be a guarantee or
27	promise of an actual projected amount. THE STATEMENT MAY INCLUDE <
28	PROMISE OF AN ACTUAL PROJECTED AMOUNT. THE STATEMENT SHALL <

17	(F) AN INSTITUTION OF HIGHER EDUCATION THAT CONTRACTS WITH A <		
18	STUDENT LOAN SERVICER, INCLUDING THE PENNSYLVANIA HIGHER		
19	EDUCATION ASSISTANCE AGENCY, TO PROVIDE THE INFORMATION REQUIRED		
20	UNDER SUBSECTION (A) TO ITS STUDENTS IN THE MANNER REQUIRED		
21	UNDER SUBSECTION (E) SHALL BE DEEMED TO HAVE COMPLIED WITH THE		
22	PROVISIONS OF THIS SECTION.		
23	(G) The Department of Education shall administer and <		
24	enforce the provisions of this section.		
25	(g) (H) As used in this section, the following words and <		
26	phrases shall have the meanings given to them in this subsection		
27	unless the context clearly indicates otherwise:		
28	"Institution of higher education." As defined in section		
29	<u>118(c).</u>		
30	"Student." As defined in section 118(c).
