AN ACT

Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An <-act relating to the public school system, including certain provisions applicable as well to private and parochial 3 schools; amending, revising, consolidating and changing the laws relating thereto," in the State System of Higher Education, further providing for establishment of the State System of Higher Education and its institutions, for board of 7 governors, for the chancellor, for powers and duties of the 8 board of governors, for councils of trustees, for powers and 9 10 duties of councils of trustees and for power and duties of institution presidents. 11 AMENDING THE ACT OF MARCH 10, 1949 (P.L.30, NO.14), ENTITLED "AN <-- ACT RELATING TO THE PUBLIC SCHOOL SYSTEM, INCLUDING CERTAIN 12 13 PROVISIONS APPLICABLE AS WELL TO PRIVATE AND PAROCHIAL 14 SCHOOLS; AMENDING, REVISING, CONSOLIDATING AND CHANGING THE 15 LAWS RELATING THERETO," IN THE STATE SYSTEM OF HIGHER 16 EDUCATION, FURTHER PROVIDING FOR DEFINITIONS, FOR 17 18 ESTABLISHMENT OF THE STATE SYSTEM OF HIGHER EDUCATION AND ITS INSTITUTIONS, FOR PURPOSES AND GENERAL POWERS, FOR PROJECT 19 CONTRACTS, FOR BOARD OF GOVERNORS, FOR THE CHANCELLOR, FOR 20 POWERS AND DUTIES OF THE BOARD OF GOVERNORS, FOR COUNCILS OF 21 TRUSTEES, FOR POWERS AND DUTIES OF COUNCILS OF TRUSTEES AND 22 FOR POWER AND DUTIES OF INSTITUTION PRESIDENTS, FOR RENTAL 23 FEES AND OTHER CHARGES, FOR ANNUAL REPORT AND FOR CAMPUS 24 25 POLICE POWERS AND DUTIES AND PROVIDING FOR STUDENT RECORDS. 26 The General Assembly of the Commonwealth of Pennsylvania

27 hereby enacts as follows:

- 1 Section 1. Section 2002 A(a) introductory paragraph of the <--
- 2 act of March 10, 1949 (P.L.30, No.14), known as the Public
- 3 School Code of 1949, is amended and the section is amended by
- 4 adding subsections to read:
- 5 Section 2002 A. Establishment of the State System of Higher
- 6 Education and its Institutions. (a) Subject to the regulatory
- 7 powers conferred by law upon the State Board of Education, there-
- 8 is hereby established a body corporate and politic constituting
- 9 a public corporation and government instrumentality [which-
- 10 shall] to be known as the State System of Higher Education,
- 11 independent of the Department of Education, hereinafter referred
- 12 to as the system, which shall consist of the following
- 13 institutions and such other institutions, presently existing [or-
- 14 newly created, as may hereafter be admitted by the board in
- 15 concurrence with other agencies as required by law] or until
- 16 <u>changed as provided under subsections (a.1), (a.2), (a.3), (a.4)</u>
- 17 $\frac{\text{and } (a.5)}{\text{and } (a.5)}$
- 18 * * *
- 19 (a.1) In accordance with section 2006 A(a)(13.2), the board
- 20 shall develop policies and procedures by which the board may
- 21 create, expand, consolidate, transfer or affiliate an
- 22 <u>institution or college. Before the creation, expansion,</u>
- 23 consolidation, transfer or affiliation of an institution or
- 24 college, the board shall direct the chancellor, in consultation
- 25 with the board, to conduct a review of the financial stability
- 26 of any impacted institution or college utilizing student support
- 27 metrics, student success metrics and other financial metrics and
- 28 develop a report and recommendation related to the need for the
- 29 board to exercise the board's powers under section 2006 A(a)
- 30 (13.2). The report and recommendations shall include, but not be

- 1 <u>limited to, an analysis of the following:</u>
- 2 (1) Enrollment trends.
- 3 (2) Projections of revenues and expenditures for the current
- 4 year and the next five (5) years, both assuming the continuation
- 5 of present operations and as impacted by any recommendation for
- 6 the board to exercise the board's powers under section 2006-A(a)
- $7 \frac{(13.2)}{.}$
- 8 (3) Assets, liabilities and institutional reserves.
- 9 <u>(4) Actions undertaken to improve the financial stability of</u>
- 10 the institution or college and the financial impact of those
- 11 <u>actions.</u>
- 12 (5) Additional actions that could be taken to improve the
- 13 <u>financial stability of the institution or college, the projected</u>
- 14 <u>financial impact of those actions and whether those actions</u>
- 15 would alleviate the need for the board to exercise the board's
- 16 powers under section 2006-A(a)(13.2).
- 17 (6) The financial impact on the institution or college and
- 18 the system if no action is taken by the board to exercise the
- 19 board's powers under section 2006-A(a)(13.2).
- 20 (7) The financial impact on the surrounding community of the
- 21 institution or college if action is taken by the board to
- 22 exercise the board's powers under section 2006 A(a) (13.2).
- 23 (a.2) Upon receipt of the report and recommendation, the
- 24 board shall develop a proposed implementation plan. The proposed
- 25 implementation plan shall include the following information:
- 26 (1) Description of the proposal to exercise powers under
- 27 section 2006-A(a)(13.2).
- 28 (2) Rationale, goals and objectives of the proposal to
- 29 exercise powers under section 2006 A(a)(13.2).
- 30 (3) Method for evaluating achievement of goals and

- 1 objectives.
- 2 (4) Relation of the proposal to the mission and strategic
- 3 plan of the institution or college and system as a whole.
- 4 (5) Impacts on academic programs, nonacademic units and
- 5 accreditation.
- 6 (6) Impacts on student, faculty and staff.
- 7 (7) Impacts on the community.
- 8 <u>(8) Impacts on shared governance.</u>
- 9 <u>(9) Before and after organizational charts for all impacted</u>
- 10 institutions or colleges.
- 11 (10) Information included in the chancellor's report and
- 12 <u>recommendation under subsection (a.1).</u>
- 13 <u>(11) Timeline for the implementation plan.</u>
- 14 (a.3) The proposed implementation plan shall be approved by
- 15 a majority vote of the board. Within fourteen (14) days after
- 16 <u>issuance of the proposed implementation plan</u>, the board shall do
- 17 the following:
- 18 (1) Transmit a copy of the proposed implementation plan to
- 19 the following:
- 20 (i) chairperson and minority chairperson of the
- 21 Appropriations Committee of the Senate;
- 22 (ii) chairperson and minority chairperson of the Education
- 23 Committee of the Senate;
- 24 (iii) chairperson and minority chairperson of the
- 25 Appropriations Committee of the House of Representatives; and
- 26 (iv) chairperson and minority chairperson of the Education
- 27 Committee of the House of Representatives.
- 28 (2) Make the proposed implementation plan available for
- 29 review and solicit public comment for a period of not less than
- 30 ninety (90) days.

- 1 (a.4) The board shall consult with stakeholders, including
- 2 faculty, staff, students and administrators, and hold at least
- 3 two (2) public hearings as part of the public comment period
- 4 <u>under subsection (a.3)(2). After the public comment period and</u>
- 5 before any action may be taken pursuant to section 2006 A(a)
- 6 (13.2), the board shall consider comments made by stakeholders
- 7 <u>during the public comment period and present an implementation</u>
- 8 plan at a public meeting subject to the approval by two thirds
- 9 of the board. If the board votes to approve the implementation
- 10 plan, the board shall, within fourteen (14) days, transmit a
- 11 copy of the final implementation plan to the following:
- 12 (1) Chairperson and minority chairperson of the
- 13 Appropriations Committee of the Senate.
- 14 (2) Chairperson and minority chairperson of the Education
- 15 Committee of the Senate.
- 16 (3) Chairperson and minority chairperson of the
- 17 Appropriations Committee of the House of Representatives.
- 18 (4) Chairperson and minority chairperson of the Education
- 19 Committee of the House of Representatives.
- 20 (a.5) The timeline for implementation to be completed as
- 21 described in the final implementation plan shall be no earlier
- 22 than twelve (12) months from the date of the issuance of the
- 23 proposed implementation plan.

- 25 Section 2. Section 2004 A(a)(7) and (b) of the act are
- 26 amended, subsection (a) is amended by adding a paragraph and the
- 27 section is amended by adding a subsection to read:
- 28 Section 2004 A. Board of Governors. (a) The system shall
- 29 be governed and all of its corporate powers exercised by the
- 30 Board of Governors, which shall consist of twenty (20) members

- 1 to be appointed as follows:
- 2 * * *
- 3 (7) [Fourteen (14) members shall be appointed by the
- 4 Governor with the advice and consent of the Senate of which six-
- 5 (6) shall be selected from the citizens of the Commonwealth.
- 6 Three (3) members of the fourteen (14) shall be students whose
- 7 terms shall expire upon graduation, separation or failure to
- 8 maintain good academic standards at their institution and five
- 9 (5) of the fourteen (14) shall be trustees of constituent
- 10 institutions, however, no more than one trustee representing a
- 11 constituent institution. The student members shall be selected
- 12 from the presidents of the local campus student government-
- 13 associations, or their local equivalent.] Eleven (11) members
- 14 shall be appointed by the Governor with the advice and consent
- 15 of the Senate of which six (6) members shall be selected from
- 16 the residents of this Commonwealth and five (5) members shall be
- 17 selected from trustees of constituent institutions, except that
- 18 no more than one trustee may represent a constituent
- 19 institution. A member appointed under this subsection shall have
- 20 expertise or substantial experience in one or more area,
- 21 including postsecondary education, finance, business, nonprofit
- 22 management, law or public administration.
- 23 (8) Three (3) of the members shall be students appointed by
- 24 the board under section 2006 A(a)(13.4). The student members
- 25 shall be selected with the advice and consent of institution
- 26 presidents. A student's term shall expire upon graduation,
- 27 <u>separation or failure to maintain good academic standing at the</u>
- 28 institution in which the student is enrolled.
- 29 (b) All members of the board appointed by the Governor[,
- 30 except for the students, | shall serve for terms of four (4)

- 1 years. The Governor and Secretary of Education shall serve so
- 2 long as they continue in office. Members of the board appointed
- 3 from the General Assembly shall serve a term of office-
- 4 concurrent with their respective elective terms as members of
- 5 the General Assembly.

- 7 (d.1) A board member appointed under subsection (a) (7) may
- 8 be removed for cause by the Governor. A board member appointed
- 9 under subsection (a) (8) may be removed by the board.

- 11 Section 3. Section 2005 A(4) of the act is amended to read:
- 12 Section 2005 A. The Chancellor. The chief executive officer
- 13 of the system shall be a chancellor, who shall be employed by
- 14 the board in accordance with clause (1) of section 2006 A. In
- 15 addition to those prescribed by the board, the chancellor shall-
- 16 have the following duties:
- 17 * * *
- 18 (4) The chancellor shall assist the board in its appointment
- 19 of the presidents for the constituent institutions by submitting-
- 20 to the board the name or names of individuals recommended by the
- 21 council of trustees [of the appropriate constituent institution
- 22 who shall involve students, faculty and alumni in the interview
- 23 and selection process used to formulate their recommendation].
- 24 The chancellor shall submit to the board the recommended salary
- 25 and other proposed terms of each such appointment. The board
- 26 shall have the right to refuse the recommendation of the local-
- 27 council and to request that additional recommendations be-
- 28 submitted by the council.

- 30 Section 4. Section 2006 A(a) introductory paragraph, (5),

- 1 (14) and (15) of the act are amended and the subsection is
- 2 amended by adding paragraphs to read:
- 3 Section 2006 A. Powers and Duties of the Board of
- 4 Governors. (a) The Board of Governors shall have [overall
- 5 responsibility for planning and coordinating the development and
- 6 operation of the system. The powers and duties of the Board of
- 7 Governors shall be: plenary power to make, issue and enforce
- 8 board policies, procedures and standards for the full
- 9 management, control and conduct of the instructional,
- 10 administrative and financial affairs of the system, including
- 11 powers and duties:
- 12 * * *
- 13 (5) To [create] <u>approve</u> new undergraduate and graduate
- 14 degree programs, which shall not be subject to the rules and
- 15 regulations of the State Board of Education; to approve
- 16 extension campuses and new external degree programs subject to-
- 17 the rules and regulations of the State Board of Education; to
- 18 promote cooperation among institutions, including the
- 19 development of consortia within the system and other educational
- 20 institutions and agencies.

- 22 (13.2) To create, expand, consolidate, transfer or affiliate
- 23 an institution or college.
- 24 (13.3) To require institutions to share services and to
- 25 <u>participate in collaborations.</u>
- 26 (13.4) To appoint student members to the board and councils.
- 27 (14) To make all reasonable [rules and regulations] policies
- 28 <u>and procedures</u> necessary to carry out the purposes of this-
- 29 article and the duties of the board.
- 30 (15) To do and perform generally all of those things

- 1 necessary and required to accomplish the role and objectives of
- 2 the system, unless otherwise delegated by the board to the
- 3 <u>chancellor</u>.
- 4 * * *
- 5 Section 5. Sections 2008 A, 2009 A and 2010 A introductory
- 6 paragraph, (1), (5), (10.1), (11), (12), (13) and (14) of the
- 7 act are amended to read:
- 8 Section 2008 A. Councils of Trustees. (a) The council of
- 9 each of the institutions shall consist of eleven (11) members
- 10 who, except for student members, shall be nominated and
- 11 appointed by the Governor with the advice and consent of the
- 12 Senate. At least two (2) members of the eleven (11) member-
- 13 council of trustees shall be alumni of the institution. Except
- 14 <u>for student trustees, a trustee appointed under this subsection</u>
- 15 shall have expertise or substantial experience in one or more
- 16 <u>area, including postsecondary education, finance, business,</u>
- 17 nonprofit management, law or public administration.
- (b) [Ten (10) members of each council shall serve terms of
- 19 six (6) years, respectively, and until their respective
- 20 successors are duly appointed and qualified. One (1) member of
- 21 each council shall be a full-time undergraduate student in good-
- 22 academic standing, other than freshman, enrolled for at least
- 23 twelve (12) semester hours at the institution of which he is a
- 24 trustee. The student member shall serve a term of four (4) years
- 25 or for so long as he is a full-time undergraduate student in-
- 26 attendance at the institution of which he is a trustee,
- 27 whichever period is shorter, and is in good academic standing.
- 28 Vacancies occurring before the expiration of the term of any
- 29 member shall be filled in like manner for the unexpired term.
- 30 Student members of the Council of Trustees shall be appointed by

- 1 the Governor and shall not be subject to Senate confirmation. If
- 2 a student member is temporarily unable, for medical or valid
- 3 academic reasons, to fulfill the responsibilities of office, the
- 4 Council of Trustees may request that the Governor appoint an
- 5 otherwise qualified student to serve as an alternate until the
- 6 return of the student member.
- 7 (c) The members of each board of trustees of a former State
- 8 college or university serving in such capacity on the effective
- 9 date of this act shall continue to serve for the balance of
- 10 their respective terms.] Ten (10) members of each council shall
- 11 <u>serve terms of four (4) years, respectively and until their</u>
- 12 <u>respective successors are duly appointed.</u>
- 13 (b.1) One (1) member of each council shall be a student
- 14 appointed by the board under section 2006 A(a) (13.4). The
- 15 student member shall serve a term of four (4) years or for so
- 16 long as the student is a full-time student in attendance at the
- 17 institution of which the student is a trustee, whichever period
- 18 is shorter, and is in good academic standing. If a student
- 19 member is temporarily unable, for medical or valid academic
- 20 reasons, to fulfill the responsibilities of office, the Council
- 21 of Trustees may appoint an otherwise qualified student to serve
- 22 <u>as an alternate until the return of the student member.</u>
- 23 (b.2) A trustee appointed under subsections (a) and (b.1)
- 24 may be removed for cause by the Governor.
- 25 (b.3) Vacancies occurring before the expiration of the term
- 26 of any member shall be filled in like manner for the unexpired
- 27 <u>term.</u>
- 28 (d) Six (6) members of a council shall constitute a quorum.
- 29 Each council shall select from its members a chairperson and a
- 30 secretary to serve at the pleasure of the council. Each council-

- 1 shall meet at least quarterly, and additionally at the call of
- 2 the president, or its chairperson, or upon request of three (3)
- 3 of its members.
- 4 Section 2009 A. Powers and Duties of Councils of Trustees.
- 5 <u>(a)</u> In accordance with [the rules and regulations] policies,
- 6 procedures and standards adopted by the board, the council of
- 7 each institution shall have the power and its duty shall be:
- 8 (1) To make recommendations to the chancellor for the
- 9 appointment[,] and retention [or dismissal] of the president
- 10 following [consultation with] input by students, faculty, staff
- 11 and alumni.
- 12 (1.1) To make recommendations to the chancellor for the
- 13 <u>dismissal of the president.</u>
- 14 (2) To assist the president in developing proper relations
- 15 and understanding between the institution and its programs and
- 16 the public, in order to serve the interests and needs of both.
- 17 [(3) To review and approve the recommendations of the
- 18 president as to standards for the admission, discipline and
- 19 expulsion of students.
- 20 (4) To review and [approve the recommendations of] provide
- 21 <u>input to</u> the president pertaining to policies and procedures
- 22 governing the use of institutional facilities and property.
- 23 (5) To approve schools and academic programs.
- 24 (6) To review and approve the recommendations of the
- 25 president pertaining to annual operating and capital budget
- 26 requirements for forwarding to the board.
- 27 (7) To review and approve charges for tuition, room and
- 28 board and other fees except student activity fees and any fees
- 29 <u>related to the provision of contracted health services</u>.
- 30 [(8) To conduct an annual physical inspection of facilities

- 1 and make recommendations regarding maintenance and construction
- 2 to the board.
- 3 (9) To review [and approve all] contracts and purchases
- 4 negotiated or awarded by the president, including any contract
- 5 or purchase reports, with or without competitive bidding and all-
- 6 contracts for consultative services entered by the president.
- 7 (10) To represent the institution at official functions of
- 8 the Commonwealth.
- 9 (11) To take such other action as may be necessary to
- 10 effectuate the powers and duties herein delegated.
- 11 (12) In accordance with the evaluation procedure established
- 12 by the board each council shall conduct an evaluation of the
- 13 president and forward the results of that evaluation with-
- 14 recommendation to the chancellor for submission to the board.
- 15 (13) By resolution adopted by the council to authorize
- 16 campus police who have completed firearms training in accordance-
- 17 with 53 Pa.C.S. § 2167(a) (relating to police training) to carry
- 18 firearms in the course of duty for any institution whose campus
- 19 police are authorized to carry firearms on the effective date of
- 20 this paragraph, the authority to carry firearms shall remain in
- 21 effect unless the council by resolution dissolves such-
- 22 authority.
- 23 Section 2010 A. Power and Duties of Institution
- 24 Presidents. The president of each institution shall be
- 25 appointed by the board. The president shall be the chief
- 26 executive officer of that institution. [He] The president shall
- 27 have the right to attend all meetings of the council of that
- 28 institution and shall have the right to speak on all matters
- 29 before the council but not to vote. Subject to the stated
- 30 authority of the board and the council, each president shall

- 1 have the following powers and duties:
- 2 (1) Except insofar as such matters are governed by
- 3 collective bargaining agreements entered pursuant to the act of
- 4 July 23, 1970 (P.L.563, No.195), known as the "Public Employe"
- 5 Relations Act," and subject to the policies of the board, to
- 6 appoint such employes, professional and noninstructional,
- 7 graduate assistants, etc. as necessary, to fix the salaries and
- 8 [benefits of employes, professional and noninstructional, and to
- 9 establish policies and procedures governing employment rights,
- 10 promotion, dismissal, tenure, leaves of absence, grievances and]
- 11 salary schedules.

- 13 (5) To establish policies and procedures governing the use
- 14 of institutional facilities and property in [accordance with-
- 15 quidelines established by consultation with the local council.
- 16 * * *
- 17 (10.1) Within the limitations of the operating budget and
- 18 other available funds in accordance with the procedures
- 19 established by the board [and with the approval of the local-
- 20 council, to negotiate and award all contracts for equipment,
- 21 services and supplies in excess of a cost of a base amount of
- 22 eighteen thousand five hundred dollars (\$18,500), subject to-
- 23 adjustment under section [120] 2003-A.1(c.3), on a competitive-
- 24 bid basis [and]. Contracts to purchase instructional,
- 25 educational, extracurricular, technical, administrative,
- 26 custodial and maintenance equipment and supplies not in excess-
- 27 of a cost of a base amount of eighteen thousand five hundred
- 28 dollars (\$18,500), subject to adjustment under section [120]
- 29 2003 A.1(c.3), may be procured, without competitive bidding,
- 30 except that such items shall not be bought in series to avoid

- 1 the dollar ceiling.
- 2 (11) To cooperate with and accept grants and assistance from
- 3 Federal and State agencies, local governments or other political
- 4 subdivisions, foundations, corporations, or any other source for
- 5 any of the lawful purposes of the institution. Each institution
- 6 shall have the power to bank and use such grants as directed by
- 7 the grantor in accordance with applicable board policy and
- 8 subject to the limitations of this act[, except that grants and
- 9 assistance from sources other than State agencies, local-
- 10 governments or other political subdivisions shall not be subject
- 11 to the provisions of clause (10)]. All moneys received from
- 12 sources authorized by this section are hereby appropriated to
- 13 each of the several institutions granted such moneys. All such
- 14 moneys shall be subject to audit by the Auditor General.
- 15 (12) To authorize personnel to travel within or without the
- 16 Commonwealth at institutional expense [in accordance with-
- 17 regulations of the council].
- 18 (13) Within the limitations of the operating budget and
- 19 other available funds, to enter into contracts for consultative-
- 20 service [not to exceed five thousand dollars (\$5,000) per
- 21 contract].
- 22 (14) To enter into contracts [in accordance with policies of
- 23 the council, 1 to enable students to engage in student teaching
- 24 or other training in order to obtain experience in a particular-
- 25 field.

- 27 Section 6. All acts and parts of acts are repealed and all
- 28 regulations and parts of regulations are abrogated insofar as
- 29 they are inconsistent with this act.
- 30 Section 7. This act shall take effect in 60 days.

- 19 SECTION 2. SECTION 2002-A OF THE ACT IS AMENDED TO READ:
