AN ACT

- 1 Providing for bisphenol A-free container products for infants.
- 2 The General Assembly of the Commonwealth of Pennsylvania
- 3 hereby enacts as follows:
- 4 Section 1. Short title.
- 5 This act shall be known and may be cited as the BPA-free
- 6 Container Products for Infants Act.
- 7 Section 2. Definitions.
- 8 The following words and phrases when used in this act shall
- 9 have the meanings given to them in this section unless the
- 10 context clearly indicates otherwise:
- "Container." A food or beverage container that serves as a
- 12 package, parcel or other vessel intended for use in storing,
- 13 heating or serving liquids or solids intended for consumption by
- 14 infants.
- "Infant." A child under one year of age.
- 16 Section 3. Bisphenol A-free food and beverage containers for
- infants.
- 18 (a) General rule. -- No person or entity may manufacture, sell

- 1 or distribute any container intended for use by infants that
- 2 contains bisphenol A (BPA) at a level above 0.1 parts per
- 3 billion (ppb).
- 4 (b) Manufacturer standard. -- A manufacturer under this
- 5 section:
- 6 (1) Shall use the least toxic alternative when replacing
- 7 BPA in containers as provided under this section.
- 8 (2) May not replace BPA with carcinogens rated by the
- 9 Environmental Protection Agency as A, B or C carcinogens or
- 10 substances listed as known or likely carcinogens, known to be
- 11 human carcinogens, likely to be human carcinogens or
- 12 suggestive of being human carcinogens, as described by the
- 13 Environmental Protection Agency in the Integrated Risk
- 14 Information System.
- 15 (3) May not replace BPA with reproductive toxicants that
- 16 cause birth defects, reproductive harm or developmental harm,
- 17 as identified by the Environmental Protection Agency.
- 18 Section 4. Violation of Unfair Trade Practices and Consumer
- 19 Protection Law.
- 20 A violation of section 3 constitutes unfair methods of
- 21 competition and unfair or deceptive acts or practices within the
- 22 meaning of section 2(4) of the act of December 17, 1968
- 23 (P.L.1224, No.387), known as the Unfair Trade Practices and
- 24 Consumer Protection Law, and shall be subject to the enforcement
- 25 provisions, civil penalties and private rights of action
- 26 contained in that act.
- 27 Section 5. Effective date.
- This act shall take effect in 60 days.
