AN ACT

- Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain provisions applicable as well to private and parochial 3 schools; amending, revising, consolidating and changing the 4 laws relating thereto," in vocational education, further 5 providing for advisory committees. 6 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 9 Section 1. Section 1842 of the act of March 10, 1949 10 (P.L.30, No.14), known as the Public School Code of 1949, is 11 amended to read: 12 Section 1842. Advisory Committees. -- (a) Each area 13 vocational-technical board operating an area vocational-14 technical school and/or technical institute shall appoint an

advisory committee, composed of representatives of local trades,

18 districts. The advisory committee shall advise the area

- 1 vocational-technical board on such matters as the need for a
- 2 particular shop, laboratory, occupation, equipment, curriculum,
- 3 labor management coordination, business and industrial
- 4 requirements or selection of personnel.
- 5 (b) An occupational advisory committee shall be established
- 6 for each career and technical education program or cluster of
- 7 <u>related career and technical education programs offered by an</u>
- 8 <u>area vocational-technical school or school district. The</u>
- 9 <u>occupational advisory committee shall be appointed by the board</u>
- 10 of directors of the area vocational-technical school or school
- 11 district, as applicable. A majority of the members of the
- 12 occupational advisory committee shall be employes and employers
- 13 <u>in the occupation for which the career and technical education</u>
- 14 program is provided. Each occupational advisory committee shall
- 15 meet at least twice each year to:
- 16 (1) advise the board of directors, administrators and staff
- 17 on curriculum, equipment, instructional materials, safety
- 18 requirements, program evaluation and other related matters; and
- 19 (2) verify that the programs meet industry standards and, if
- 20 appropriate, licensing board criteria, and that the programs
- 21 prepare students with occupation-related competencies.
- 22 <u>(c) Notwithstanding subsection (b), to increase employer</u>
- 23 participation in an occupational advisory committee required
- 24 under this section, the boards of directors of multiple area
- 25 <u>vocational-technical schools or school districts operating</u>
- 26 career and technical education programs may agree to establish a
- 27 shared occupational advisory committee to serve all agreeing
- 28 area vocational-technical schools or school districts, provided
- 29 that all agreeing area vocational-technical schools or school
- 30 districts are located within the same intermediate unit. If a

- 1 shared occupational advisory committee is formed under this
- 2 <u>subsection</u>, the occupational advisory committee shall be
- 3 <u>designed to provide equal opportunities for all agreeing area</u>
- 4 <u>vocational-technical schools or school districts to participate,</u>
- 5 <u>including scheduling meetings at each area vocational-technical</u>
- 6 school or school district on a rotating basis.
- 7 Section 2. This act shall take effect in 60 days.
