AN ACT

- Amending the act of April 9, 1929 (P.L.177, No.175), entitled 1 "An act providing for and reorganizing the conduct of the 2 executive and administrative work of the Commonwealth by the 3 Executive Department thereof and the administrative departments, boards, commissions, and officers thereof, including the boards of trustees of State Normal Schools, or 5 6 Teachers Colleges; abolishing, creating, reorganizing or 7 authorizing the reorganization of certain administrative 8 9 departments, boards, and commissions; defining the powers and duties of the Governor and other executive and administrative 10 officers, and of the several administrative departments, 11 boards, commissions, and officers; fixing the salaries of the 12 Governor, Lieutenant Governor, and certain other executive 13 and administrative officers; providing for the appointment of 14 certain administrative officers, and of all deputies and 15 other assistants and employes in certain departments, boards, 16 and commissions; providing for judicial administration; and 17 prescribing the manner in which the number and compensation 18 19 of the deputies and all other assistants and employes of certain departments, boards and commissions shall be 20 determined," in Independent Fiscal Office, further providing 21 for definitions and for duties of office. 22 23 The General Assembly of the Commonwealth of Pennsylvania 24 hereby enacts as follows: 25 Section 1. Section 602-B of the act of April 9, 1929 26 (P.L.177, No.175), known as The Administrative Code of 1929, is

- 7 magnitude which, if not dealt with, may negatively affect the
- 8 ability of the State to continue to meet financial obligations.

- 10 Section 2. Section 604-B(a)(2) of the act is amended AND THE <--
- 11 SUBSECTION IS AMENDED BY ADDING A PARAGRAPH to read:
- 12 Section 604-B. Duties of office.
- 13 (a) Mandatory.--The office shall:
- 14 * * *
- 15 (2) By November 15 of each year, provide an assessment
- of the State's current fiscal condition and a projection of
- 17 what the fiscal condition will be during the next five years.
- 18 The assessment shall take into account the state of the
- economy, demographics, revenues [and], expenditures and
- 20 critical risk factors of importance for the financial well-
- 21 being of the State.

- 23 (9) COMPILE INFORMATION TO TRACK MONEY DISTRIBUTED BY
- 24 THE FEDERAL GOVERNMENT TO ENTITIES WITHIN THIS COMMONWEALTH
- 25 UNDER THE CORONAVIRUS AID, RELIEF, AND ECONOMIC SECURITY ACT
- 26 (PUBLIC LAW 116-136, 134 STAT. 281) THAT WAS NOT RECEIVED
- 27 DIRECTLY BY OR ORIGINALLY DEPOSITED INTO AN ACCOUNT OF THE
- 28 COMMONWEALTH OR AN AGENCY OF THE COMMONWEALTH. THE OFFICE
- 29 <u>SHALL REGULARLY PROVIDE THIS INFORMATION TO THE CHAIRPERSON</u>
- 30 AND MINORITY CHAIRPERSON OF THE APPROPRIATIONS COMMITTEE OF

- 1 THE SENATE AND THE CHAIRPERSON AND MINORITY CHAIRPERSON OF
- THE APPROPRIATIONS COMMITTEE OF THE HOUSE OF REPRESENTATIVES.
- 3 THE OFFICE SHALL POST THIS INFORMATION TO THE OFFICE'S
- 4 PUBLICLY AVAILABLE INTERNET WEBSITE. THIS PARAGRAPH SHALL
- 5 EXPIRE ON DECEMBER 31, 2021.

- 7 Section 3. This act shall take effect in 60 days.
