AN ACT

- Amending the act of June 28, 1935 (P.L.477, No.193), entitled
 "An act providing for the payment of the salary, medical and hospital expenses of certain employes of State and local government who are injured or contract certain diseases in the performance of their duty; and providing that absence during such injury shall not reduce any usual sick leave period," further providing for disability benefits.

- 2 <u>quarantine resulting from exposure to COVID-19</u>, and by reason
