AN ACT

- 1 Providing for health care facility reporting relating to COVID-
- 2 19 and for duties of the Department of Health and the
- 3 Department of Human Services.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Short title.
- 7 This act shall be known and may be cited as the Emergency
- 8 Declaration Data Transparency Act.
- 9 Section 2. Definitions.
- 10 The following words and phrases when used in this act shall
- 11 have the meanings given to them in this section unless the
- 12 context clearly indicates otherwise:
- 13 "Care." Services provided to meet a recipient's need for
- 14 personal care or health care which requires interaction with the
- 15 recipient.
- 16 "COVID-19." The novel coronavirus as identified in the
- 17 Governor's proclamation of disaster emergency issued on March 6,

- 1 2020.
- 2 "Employee." An individual who is:
- 3 (1) employed by a facility, or the affiliated corporate
- 4 entity of a facility, or enters into a contractual
- 5 relationship with the facility, recipient, a recipient's
- family, agent, legal representative or the affiliated
- 7 corporate entity of a facility, to provide care to a
- 8 recipient;
- 9 (2) has unsupervised access to another individual and
- 10 that individual's living quarters, resources or personal
- 11 records; or
- 12 (3) is a student doing an internship or clinical
- 13 rotation or any other individual who has been granted access

- 14 to a facility or older adult to perform a clinical service
- for a fee paid by the facility.
- 16 "Facility." Any of the following:
- 17 (1) Any of the following entities as defined in section
- 18 802.1 of the act of July 19, 1979 (P.L.130, No.48), known as
- 19 the Health Care Facilities Act:
- 20 (i) A long-term care nursing facility.
- 21 (ii) A hospice.
- 22 (2) A personal care home as defined in section 1001 of
- the act of June 13, 1967 (P.L.31, No.21), known as the Human
- 24 Services Code.
- 25 (3) An assisted living residence as defined in section
- 26 1001 of the Human Services Code.
- 27 "Recipient." An individual who receives care, services or
- 28 treatment in or from a facility.
- 29 Section 3. Facility reporting requirements.
- 30 (A) GENERAL RULE. -- A facility shall report COVID-19 related <--

- 1 data to and in accordance with the appropriate licensing
- 2 department IN THE SAME MANNER THE FACILITY CURRENTLY REPORTS

- 3 SPECIFIC IDENTIFIED AND REPORTABLE DISEASES, INFECTIONS AND
- 4 CONDITIONS, as follows:
- 5 (1) A long-term care nursing facility or hospice shall
- 6 report an outbreak of a serious communicable disease as
- 7 defined in 28 Pa. Code § 27.2 (relating to specific
- 8 identified and reportable diseases, infections and
- 9 conditions).
- 10 (2) A personal care home or assisted living residence
- shall report an outbreak of a serious communicable disease as
- defined in 28 Pa. Code § 27.2.
- 13 (B) COVID-19 DATA.--FOR THE PURPOSES OF THIS SECTION, COVID- <--
- 14 19 RELATED DATA SHALL INCLUDE THE NUMBER OF POSITIVE COVID-19
- 15 CASES AND THE NUMBER OF DEATHS AS A RESULT OF COVID-19 AMONG
- 16 EMPLOYEES AND RECIPIENTS.
- 17 Section 4. Isolation protocol and infection control
- 18 requirements.
- 19 (a) Collection of data. -- The Department of Health shall
- 20 summarize the infection control measures taken by each facility
- 21 to mitigate the spread of COVID-19 in accordance with the
- 22 infection control and isolation protocols as reported by the
- 23 facility to the appropriate licensing department implemented.
- 24 (b) Publication. -- The data collected under this section
- 25 shall be published on the Department of Health's publicly
- 26 accessible Internet website.
- 27 (c) Local health departments. -- Nothing in this section shall
- 28 prohibit a local health department from publishing the
- 29 information under this section on its publicly accessible
- 30 Internet website.

- 1 Section 5. Data publication.
- 2 (a) Duty of department. -- The EXCEPT AS PROVIDED UNDER
- 3 SUBSECTION (B), THE Department of Health shall collect the
- 4 information required to be reported under section 3 and make the

- 5 following data available on the department's publicly accessible
- 6 Internet website:
- 7 (1) The number of recipients who have tested positive
- 8 for COVID-19 in each facility.
- 9 (2) The number of recipients who have died as a result
- of COVID-19 in each facility.
- 11 (3) The number of employees who have tested positive for
- 12 COVID-19 working in each facility.
- 13 (4) The number of employees working in each facility who
- have died as a result of COVID-19.
- 15 (B) FACILITIES WITH LOW CASE NUMBERS.--IF A FACILITY REPORTS <--
- 16 LESS THAN FIVE POSITIVE CASES OR DEATHS RELATED TO COVID-19
- 17 UNDER SECTION 3, THE DEPARTMENT OF HEALTH SHALL NOT BE REQUIRED
- 18 TO LIST THE NUMBERS AS PROVIDED UNDER SUBSECTION (A) AND MAY
- 19 ONLY INDICATE THAT THE FACILITY HAS LESS THAN FIVE REPORTED
- 20 CASES OR DEATHS RELATED TO COVID-19 ON ITS PUBLICLY ACCESSIBLE
- 21 INTERNET WEBSITE.
- 22 (b) (C) Construction. -- Nothing in this section shall
- 23 prohibit a local health department from publishing the data in
- 24 this section on its publicly accessible Internet website.
- 25 SECTION 6. CONSTRUCTION.
- 26 NOTHING IN THIS ACT SHALL BE CONSTRUED TO INTERFERE WITH THE
- 27 MANDATORY INVESTIGATORY REQUIREMENTS OF A CORONER UNDER SECTION
- 28 1218-B(A)(7) OF THE ACT OF AUGUST 9, 1955 (P.L.323, NO.130),
- 29 KNOWN AS THE COUNTY CODE.
- 30 Section 6 7. Expiration.

- 1 This act shall expire upon termination, by executive order,
- 2 proclamation or operation of law, of the declaration of disaster
- 3 emergency issued by the Governor on March 6, 2020, published at

- 4 50 Pa.B. 1644 (March 21, 2020).
- 5 Section 7 8. Effective date.

6 This act shall take effect immediately.
