## AN ACT

Amending the act of April 9, 1929 (P.L.343, No.176), entitled "An act relating to the finances of the State government; 2 providing for cancer control, prevention and research, for 3 ambulatory surgical center data collection, for the Joint Underwriting Association, for entertainment business 5 financial management firms, for private dam financial 6 assurance and for reinstatement of item vetoes; providing for 7 the settlement, assessment, collection, and lien of taxes, 8 bonus, and all other accounts due the Commonwealth, the 9 collection and recovery of fees and other money or property 10 due or belonging to the Commonwealth, or any agency thereof, 11 including escheated property and the proceeds of its sale, 12 the custody and disbursement or other disposition of funds 13 and securities belonging to or in the possession of the 14 Commonwealth, and the settlement of claims against the 15 Commonwealth, the resettlement of accounts and appeals to the 16 courts, refunds of moneys erroneously paid to the 17 Commonwealth, auditing the accounts of the Commonwealth and 18 all agencies thereof, of all public officers collecting 19 moneys payable to the Commonwealth, or any agency thereof, 20 and all receipts of appropriations from the Commonwealth, 21 authorizing the Commonwealth to issue tax anticipation notes 22 to defray current expenses, implementing the provisions of 23 24 section 7(a) of Article VIII of the Constitution of 25 Pennsylvania authorizing and restricting the incurring of certain debt and imposing penalties; affecting every 26 department, board, commission, and officer of the State 27 government, every political subdivision of the State, and 28

- certain officers of such subdivisions, every person, 1 association, and corporation required to pay, assess, or 2 collect taxes, or to make returns or reports under the laws 3 imposing taxes for State purposes, or to pay license fees or 4 other moneys to the Commonwealth, or any agency thereof, 5 every State depository and every debtor or creditor of the 7 Commonwealth," providing for small business grant program, imposing duties on the Department of Community and Economic 8 Development; and making an appropriation. 9 The General Assembly of the Commonwealth of Pennsylvania 10 11 hereby enacts as follows: 12 Section 1. The act of April 9, 1929 (P.L.343, No.176), known 13 as The Fiscal Code, is amended by adding an article to read: 14 ARTICLE I-B 15 SMALL BUSINESS GRANT PROGRAM Section 101-B. Definitions. 16 17 The following words and phrases when used in this article 18 shall have the meanings given to them in this section unless the 19 context clearly indicates otherwise: 20 "Department." The Department of Community and Economic <u>Development of the Commonwealth.</u> 2.1 22 "REGIONAL NETWORK." A DEPARTMENT ECONOMIC DEVELOPMENT <--23 SERVICE PROVIDER, INCLUDING, BUT NOT LIMITED TO, INDUSTRIAL 24 DEVELOPMENT ORGANIZATIONS, LOCAL DEVELOPMENT DISTRICTS AND SMALL 25 BUSINESS DEVELOPMENT CENTERS. 26 within this Commonwealth: 27 28 (1) whose gross annual receipts for the prior fiscal
- 29 year did not exceed \$3,000,000; and \$1,500,000; OR
- (2) that employs no more than 30 10 full-time employees. <--30

- Section 102-B. Grants and funding. 31
- 32 (a) Purpose. -- The department shall provide grants in
- 33 accordance with this article to REGIONAL NETWORKS FOR THE
- PURPOSE OF ADMINISTERING AND FUNDING A REGIONAL SMALL BUSINESS 34

- 1 GRANT PROGRAM PURSUANT TO WHICH GRANTS WILL BE PROVIDED TO small
- 2 <u>businesses</u> that are adversely affected financially due to the
- 3 coronavirus pandemic and the proclamation of disaster emergency
- 4 issued by the Governor on March 6, 2020, published in 50 Pa.B.
- 5 <u>1644 (March 21, 2020), and any renewal of the state of disaster</u>
- 6 <u>emergency</u>.
- 7 (B) REGIONAL SMALL BUSINESS GRANT PROGRAM. -- REGIONAL

- 9 REGIONAL SMALL BUSINESS GRANT PROGRAM IN ACCORDANCE WITH

- 11 (b) (C) Amount. -- Subject to the availability of State money, <--
- 12 <u>a grant FROM A REGIONAL NETWORK to a small business under this</u> <--
- 13 section shall not exceed \$15,000.
- 14 Section 103-B. Application form.
- 15 (a) Development of forms. -- The department shall develop a
- 16 <u>REGIONAL SMALL BUSINESS grant application form for small</u>
- <--
- 17 <u>businesses to apply TO REGIONAL NETWORKS for a grant under this</u> <--
- 18 <u>article</u>.
- 19 (b) Contents of form.--At a minimum, the REGIONAL SMALL <--
- 20 BUSINESS grant application form shall contain the following
- 21 information:
- 22 (1) The name, address and contact information of the
- 23 small business.
- 24 (2) The amount of grant money requested.
- 25 (3) The proposed use for the grant money requested.
- 26 (4) The financial impact of the coronavirus pandemic and
- 27 the proclamation of disaster emergency issued by the Governor
- 28 on March 6, 2020, published in 50 Pa.B. 1644 (March 21,
- 29 2020), and any renewal of the state of disaster emergency, on
- 30 the small business.

1	(5) Any other information that the department deems
2	necessary and appropriate.
3	Section 104-B. Public notice.
4	The department shall provide information regarding the
5	availability and award of grant money on the department's
6	publicly accessible Internet website.
7	Section 105-B. Award of grants.
8	(a) Criteria After review of the information specified
9	under section 103-B and within 20 days of the submission of the
10	grant application, the department REGIONAL NETWORK shall <
11	determine whether to award grant money to the small business
12	and, if so, the amount of the grant money awarded.
13	(b) Considerations In awarding grant money to a small
14	business, the department REGIONAL NETWORK:
15	(1) Shall consider the geographic and demographic
16	diversity of the small businesses applying for the grant
17	money.
18	(2) Shall consider how the small business and other
19	persons would be served through the award of the grant to the
20	small business.
21	(3) May require documentation of gross annual receipts
22	and employee information for the small business.
23	(c) Notice
24	(1) The department REGIONAL NETWORK shall provide <
25	written notice to the small business of the award or denial
26	of the grant money.
27	(2) Notice of the award of grant money shall include the
28	amount of the grant money awarded and any conditions or

- 3 (4) THE REGIONAL NETWORK SHALL PROVIDE COPIES OF ALL <--
- 4 NOTICES TO THE DEPARTMENT WHEN THEY ARE PROVIDED TO THE SMALL
- 5 BUSINESSES AND SHALL PROVIDE OTHER DOCUMENTS, INFORMATION AND
- 6 <u>DATA TO THE DEPARTMENT IMMEDIATELY UPON REQUEST.</u>
- 7 <u>Section 106-B. Reports.</u>
- 8 (a) Preparation.--By September 30, 2020, or 60 days after
- 9 the expiration of this article, whichever occurs later, the
- 10 <u>department shall prepare a report that lists each REGIONAL</u> <--
- 11 NETWORK AND small business that received grant money under this
- 12 <u>article and a summary of the information specified under section</u>
- 13 <u>103-B(b)</u>.
- 14 (b) Publication. -- The report under this section shall be
- 15 posted on the department's publicly accessible Internet website.
- 16 Section 107-B. Guidelines.
- 17 The department may promulgate guidelines for the
- 18 implementation and administration of this article.
- 19 Section 108-B. Appropriation.
- The sum of \$50,000,000 is hereby appropriated to the
- 21 department to carry out the provisions of ADMINISTER AND FUND <--
- 22 THE GRANT PROGRAM CREATED BY this article.
- 23 Section 109-B. Expiration.
- 24 This article shall expire on September 30, 2020, or 30 days
- 25 after the termination of the declaration of disaster emergency
- 26 under 35 Pa.C.S. § 7301(c) (relating to general authority of
- 27 Governor), whichever occurs later.
- 28 Section 2. This act shall take effect immediately.
