Assessment of fees.--Notwithstanding any other provision 5 (a) of law, the board shall prorate and reduce the amount of fees 6 7 assessed under all of the following based on the duration of the 8 proclamation of disaster emergency: 9 Section 614-A of the act of April 9, 1929 (P.L.177, (1)No.175), known as The Administrative Code of 1929. 10 Sections 405, 409, 410, 435, 439, 469, 504, 508, 11 (2) 12 704, 707 and 723 of the act of April 12, 1951 (P.L.90, 13 No.21), known as the Liquor Code. 14 (b) Payments. -- Notwithstanding any other provision of law, 15 the fees assessed under the provisions specified under 16 subsection (a) shall be due January 1, 2021. 17 Section 4. Temporary regulations. Temporary regulations. -- In order to facilitate the 18 (a) 19 prompt implementation of this act, the board may promulgate 20 temporary regulations within 30 days of the effective date of 21 this section. The temporary regulations shall expire no later than 30 days after the publication of the temporary regulations. 22 23 The temporary regulations shall not be subject to any of the 24 following: 25 Section 612 of the act of April 9, 1929 (P.L.177, (1)26 No.175), known as The Administrative Code of 1929. 27 Sections 201, 202, 203, 204 and 205 of the act of (2)July 31, 1968 (P.L.769, No.240), referred to as the 28 29 Commonwealth Documents Law.

5 Section 5. Notice of prorated and reduced liquor control fees.
6 No later than 30 days from the effective date of this act,
7 the board shall provide notice of the prorated and reduced fees
8 under section 3 on the board's publicly accessible Internet
9 website.

10 Section 6. Effective date.

11 This act shall take effect immediately.
