AN ACT

- Amending the act of November 22, 1978 (P.L.1166, No.274), entitled "An act establishing the Pennsylvania Commission on Crime and Delinquency, providing for its powers and duties 3 establishing several advisory committees within the commission and providing for their powers and duties," 4 providing for Women and Girls Committee. 6 7 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 9 Section 1. Women and Girls Committee. (a) Establishment. -- The Women and Girls Committee is 13

- 15 <u>(d) Number.--The committee shall consist of no less than</u>
- 16 nine members and no more than 15 members.
- 17 (e) Quorum.--A majority of the members shall constitute a
- 18 guorum and a vote of the majority of the members present shall
- 19 be sufficient for all actions.
- 20 (f) Chairperson. -- The chairperson of the commission shall
- 21 appoint a committee chairperson from among the members of the
- 22 committee who shall serve at the pleasure of the chairperson of
- 23 the commission. A vice chairperson shall be designated by the
- 24 chairperson and preside at meetings in the absence of the
- 25 chairperson. The committee shall meet at the call of the
- 26 chairperson, but not less than two times annually.
- 27 (q) Powers and duties. -- The Women and Girls Committee shall:
- 28 (1) Share research, program development, policy changes,
- 29 data and other information originating in each committee or
- 30 subcommittee on topics affecting system-involved girls and
