AN ACT

- 1 Authorizing the Department of General Services, with the
- approval of the Governor and the Department of Military and
- Weterans Affairs, to grant and convey, at a price to be
- 4 determined through a competitive bid process, certain lands,
- buildings and improvements situate in Allegheny Township,
- 6 Blair County.
- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 Section 1. Conveyance in Allegheny Township, Blair County.
- 10 (a) Authorization. -- The Department of General Services, with
- 11 the approval of the Governor and the Department of Military and
- 12 Veterans Affairs, is hereby authorized on behalf of the
- 13 Commonwealth of Pennsylvania to grant and convey, at a price to
- 14 be determined through competitive bidding, the following tract
- 15 of land together with any buildings, structures or improvements
- 16 thereon, situate in Allegheny Township, Blair County.
- 17 (b) Property description. -- The property to be conveyed
- 18 under subsection (a) consists of a tract of approximately
- 19 111.36-acres of land and improvements located thereon, bounded
- 20 and more particularly bounded and described as follows:

- 9 (c) Conditions. -- The conveyance shall be made under and
- 10 subject to all lawful and enforceable easements, servitudes and
- 11 rights of others, including but not confined to streets,
- 12 roadways and rights of any telephone, telegraph, water,
- 13 electric, gas or pipeline companies, as well as under and
- 14 subject to any lawful and enforceable estates or tenancies
- 15 vested in third persons appearing of record, for any portion of
- 16 the land or improvements erected thereon.
- 17 (d) Execution of deed.--The deed of conveyance shall be by
- 18 Special Warranty Deed and shall be executed by the Secretary of
- 19 General Services in the name of the Commonwealth of Pennsylvania
- 20 (e) Restrictive covenant. -- The Secretary of General Services
- 21 may impose any covenants, conditions or restrictions on the
- 22 property described under subsection (b) at settlement as
- 23 determined to be in the best interests of the Commonwealth.
- 24 (f) Proceeds.--The proceeds from the sale shall be deposited
- 25 in the General Fund.
- 26 Section 2. Effective date.
- 27 This act shall take effect immediately.
