AN ACT

Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An 1 act relating to the public school system, including certain 2 provisions applicable as well to private and parochial 3 schools; amending, revising, consolidating and changing the laws relating thereto," in terms and courses of study, further providing for pandemic of 2020; and establishing the 5 6 COVID-19 School Reopening Task Force. 8 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 10 Section 1. Section 1501.8 of the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, is 11 12 amended by adding a subsection to read: 13 Section 1501.8. Pandemic of 2020. -- * * * 14 (m.1) Notwithstanding any provision of law to the contrary, the following shall apply: 15 16 (1) Each school entity shall update its continuity of 17 education plan submitted to the Department of Education before 18 the beginning of the 2020-2021 school year. The updated plan shall specify a comprehensive framework for school operations in 19

anticipation of reopening school buildings and conducting in-

- 1 person instruction. The updated plan shall take into
- 2 consideration any quideline issued by the Governor and the
- 3 Secretary of Health to ensure the health and safety of students,
- 4 parents, school employes and the community. The updated plan
- 5 must include the following:
- 6 (i) Procedures to provide the continuation of education plan
- 7 to students using alternative means during any period of closure
- 8 <u>in the future and specific information regarding technology</u>
- 9 resources that will be used to deliver education.
- 10 (ii) Procedures for a student who receives services under an
- 11 <u>individualized education plan to ensure the student receives a</u>
- 12 free and appropriate public education as required by law.
- 13 <u>(iii) An assessment of each student's academic needs due to</u>
- 14 the pandemic and any compensatory instruction and services
- 15 provided.
- 16 (iv) Classroom and building operation logistics to ensure
- 17 the health and safety of students and school employes.
- 18 (v) Procedures for food distribution both in-person and
- 19 during periods of closure.
- 20 (vi) Procedures for bus transportation of students.
- 21 (vii) Procedures for training school employes on proper
- 22 cleaning and sanitation of school facilities, and the school's
- 23 protocols on providing personal protective equipment,
- 24 appropriate cleaning materials and supplies for school employes
- 25 assigned to clean the facilities.
- 26 (viii) Measures to increase counseling and mental health
- 27 services for students.
- 28 (2) The Secretary of Education, in consultation with the
- 29 <u>Secretary of Health, shall develop reopening guidelines</u>
- 30 consistent with the Governor's phases of red, yellow and green

- 1 for reopening regions in this Commonwealth. The Department of
- 2 Education shall provide quidance to school entities and
- 3 intermediate units on provisions listed in paragraph (1). The
- 4 <u>guidelines shall provide requirements each school entity must</u>
- 5 meet prior to reopening and shall be updated with the most
- 6 <u>current procedures.</u>
- 7 (3) The Department of Education may provide technical
- 8 <u>assistance needed by school entities and intermediate units.</u>
- 9 (4) A school entity shall post the plan on the school
- 10 entity's publicly accessible Internet website.
- 11 * * *
- 12 Section 2. The act is amended by adding a section to read:
- 13 <u>Section 1501.10. COVID-19 School Reopening Task Force.--(a)</u>
- 14 The COVID-19 School Reopening Task Force is established.
- 15 (b) The purpose of the task force shall be to examine all
- 16 <u>health and safety concerns regarding the successful reopening</u>
- 17 and operation of school entities during the pandemic of 2020 and
- 18 into the future, and to put Pennsylvania's students into in-
- 19 person classrooms as safely as possible.
- 20 (c) The task force shall consist of the following members:
- 21 (1) The Secretary of Education or a designee.
- 22 (2) One member appointed by the President pro tempore of the
- 23 Senate.
- 24 (3) One member appointed by the Speaker of the House of
- 25 Representatives.
- 26 (4) One member appointed by the Minority Leader of the
- 27 Senate.
- 28 (5) One member appointed by the Minority Leader of the House
- 29 <u>of Representatives.</u>
- 30 (6) The majority chairperson and the minority chairperson of

- 1 the Appropriations Committee of the Senate.
- 2 (7) The majority chairperson and the minority chairperson of
- 3 the Appropriations Committee of the House of Representatives.
- 4 (8) The majority chairperson and the minority chairperson of
- 5 the Education Committee of the Senate.
- 6 (9) The majority chairperson and the minority chairperson of
- 7 the Education Committee of the House of Representatives.
- 8 (d) All members shall be appointed within ten (10) days of
- 9 the effective date of this section.
- 10 (e) The task force shall hold an organizational meeting not
- 11 later than fifteen (15) days following the effective date of
- 12 this section.
- (f) Vacancies on the task force shall be filled by the
- 14 <u>original appointing authority.</u>
- 15 (g) The task force shall elect two (2) task force
- 16 chairpersons, one from the Senate and one from the House of
- 17 Representatives.
- 18 (h) The task force shall hold meetings at the joint call of
- 19 the chairpersons.
- 20 (i) The task force shall hold six (6) or more public
- 21 hearings on the matters to be considered by the task force. All
- 22 meetings and public hearings of the task force shall be held in
- 23 conformity with 65 Pa.C.S. Ch. 7 (relating to open meetings).
- 24 (j) Seven (7) members of the task force shall constitute a
- 25 <u>quorum at a meeting.</u>
- 26 (k) The task force members shall receive no compensation for
- 27 their services but shall be reimbursed for all necessary travel
- 28 and other reasonable expenses incurred in connection with the
- 29 performance of their duties as members.
- 30 (1) The task force shall have the following powers and

- 1 duties:
- 2 (1) Review all issues related to the safe return of students
- 3 and draft plans for school districts' use.
- 4 (2) Evaluate and make recommendations on the following:
- 5 (i) The potential staggering of school schedules to reduce
- 6 the size of classrooms and open space gatherings.
- 7 (ii) Enhanced cleaning procedures of buildings and buses.
- 8 (iii) Implementation of additional policies related to
- 9 personal protective equipment, air quality measurements and
- 10 enhanced filtration.
- 11 (iv) Meal preparation and serving procedures.
- 12 (v) After-school activity precautions to mitigate the
- 13 potential spread of germs.
- 14 (vi) Redesigning of facilities to enhance social distancing.
- 15 (vii) Procedures for student assemblies to enhance social
- 16 distancing.
- 17 (3) Assess the additional costs to implement the necessary
- 18 procedures to open schools safely.
- 19 (m) The task force shall consult with education
- 20 stakeholders, health experts, parents and other groups to create
- 21 a comprehensive report and recommendations for school entities.
- 22 The report and recommendations shall be issued not later than
- 23 July 31, 2020.
- (n) As used in this section, the following words and phrases
- 25 shall have the meanings given to them in this subsection unless
- 26 the context clearly indicates otherwise:
- 27 <u>"School entity." A school district, intermediate unit, area</u>
- 28 career and technical school, charter school, cyber charter
- 29 school or regional charter school a student attends in order to
- 30 fulfill the compulsory attendance requirements of this act.

- 1 Section 3. All regulations are abrogated to the extent of
- 2 any inconsistency with this act.
- 3 Section 4. This act shall take effect immediately.
