## AN ACT

Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An 1 act relating to the public school system, including certain 2 provisions applicable as well to private and parochial 3 schools; amending, revising, consolidating and changing the laws relating thereto," in school health services, further 5 providing for confidentiality, transference and removal of 6 health records. 8 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 10 Section 1. Section 1409 of the act of March 10, 1949 11 (P.L.30, No.14), known as the Public School Code of 1949, is 12 amended by adding a subsection to read: 13 Section 1409. Confidentiality, Transference and Removal of Health Records. --\* \* \* 14 15 (d) The following apply: (1) The Department of Health or the local board or 16 17 department of health shall report any positive or presumptive 18 case of COVID-19 that occurs in a student or an employee of a

school entity or in a provider of services or contractor who

works at the school entity to the school entity. Within twenty-

- 1 four (24) hours of receipt of the information of a positive case
- 2 of COVID-19 in an employee or a student of the school entity
- 3 under this paragraph, the school entity shall notify employees
- 4 and the parents of the students who work or receive instruction
- 5 <u>in the same school building as the COVID-19-positive employee or</u>
- 6 student of the existence of the COVID-19-positive employee or
- 7 <u>student. The school entity shall provide educational support to</u>
- 8 students who are not permitted to receive instruction at the
- 9 school entity due to a positive or presumptive case of COVID-19
- 10 within the school entity.
- 11 (2) As used in this subsection, the following words and
- 12 phrases shall have the meanings given to them in this paragraph:
- "COVID-19" means the novel coronavirus as identified in the
- 14 proclamation of disaster emergency issued by the Governor on
- 15 March 6, 2020, published at 50 Pa.B. 1644 (March 21, 2020), and
- 16 any renewal of the state of disaster emergency.
- 17 "Local board or department of health" means as the term is
- 18 defined in section 2(f) of the act of April 23, 1956 (1955)
- 19 P.L.1510, No.500), known as the "Disease Prevention and Control
- 20 Law of 1955."
- "School entity" means any school district, intermediate unit,
- 22 career and technical center, charter school, regional charter
- 23 <u>school</u>, <u>cyber charter school</u>, <u>private or nonpublic school</u>.
- 24 Section 2. This act shall take effect immediately.
