AN ACT

- Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain
- provisions applicable as well to private and parochial
- schools; amending, revising, consolidating and changing the
- laws relating thereto, " in terms and courses of study,
- 6 providing for option year of education due to COVID-19.
- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 Section 1. The act of March 10, 1949 (P.L.30, No.14), known
- 10 as the Public School Code of 1949, is amended by adding a
- 11 section to read:
- 12 Section 1501.11. Option Year of Education Due to COVID-19.--
- 13 (a) The welfare of this Commonwealth requires that the present
- 14 generation of school age children be provided ample opportunity
- 15 to develop to their fullest intellectual capacities. It is the
- 16 intent of the General Assembly to ensure that the present
- 17 generation of school age children do not lose educational

- 1 opportunities due to the proclamation of disaster emergency
- 2 <u>issued by the Governor on March 6, 2020, published at 50 Pa.B.</u>
- 3 1644 (March 21, 2020).
- 4 (b) Notwithstanding any other provision of law, for the
- 5 2021-2022 school year, a parent may elect to have a child in a
- 6 school entity repeat a grade level to make up for any lost
- 7 <u>educational opportunities during the 2019-2020 and 2020-2021</u>
- 8 school years regardless of whether the child met the
- 9 requirements to be promoted to the next grade level. The
- 10 parental election under this subsection shall include
- 11 participation in all academic or extracurricular activities.
- 12 (c) A school entity shall create a process for a parent to
- 13 make the election under subsection (b) and post the process on
- 14 <u>its publicly accessible Internet website.</u>
- 15 (d) As used in this section, the term "school entity" shall
- 16 mean a school district, intermediate unit, area career and
- 17 technical school, charter school, cyber charter school, regional
- 18 <u>charter school or nonpublic school entity.</u>
- 19 Section 2. This act shall take effect immediately.
