AN ACT

Amending Title 35 (Health and Safety) of the Pennsylvania Consolidated Statutes, in COVID-19 disaster emergency, imposing a moratorium on evictions and foreclosures; and, in 3 Commonwealth services, further providing for general 4 5 authority of Governor. 6 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 7 8 Section 1. Chapter 57 of Title 35 of the Pennsylvania Consolidated Statutes is amended by adding a subchapter to read: 10 SUBCHAPTER F 11 MORATORIUM ON EVICTIONS AND FORECLOSURES 12 Sec. 13 5751. Imposition of moratorium. 14 § 5751. Imposition of moratorium. 15 (a) General rule. -- Notwithstanding any other provision of 16 law, residential evictions and foreclosures are suspended during

the COVID-19 disaster emergency. The moratorium period shall

- 13 (f) Additional powers. -- In addition to any other powers
- 14 conferred upon the Governor by law, the Governor may:

- 16 (10) Notwithstanding any other provisions of law, place
- 17 a moratorium on evictions and foreclosures in this
- 18 Commonwealth or specific counties during a disaster
- 19 emergency. A moratorium enacted under this paragraph shall
- 20 extend for 90 days after the disaster emergency has expired
- or been terminated, unless sooner rescinded by the Governor.
