## A SUPPLEMENT

To the act of May 29, 2020 (P.L., No.1A), entitled "An act to provide appropriations from the General Fund for the expenses of the Executive, Legislative and Judicial Departments of the 3 Commonwealth, the public debt and the public schools for the 4 fiscal year July 1, 2020, to June 30, 2021, and for the payment of bills incurred and remaining unpaid at the close 6 7 of the fiscal year ending June 30, 2020; to provide appropriations from special funds and accounts to the 8 Executive and Judicial Departments for the fiscal year July 9 1, 2020, to June 30, 2021, and for the payment of bills 10 remaining unpaid at the close of the fiscal year ending June 11 30, 2020; to provide for the appropriation of Federal funds 12 to the Executive and Judicial Departments for the fiscal year 13 July 1, 2020, to June 30, 2021, and for the payment of bills 14 remaining unpaid at the close of the fiscal year ending June 15 30, 2020; and to provide for the additional appropriation of 16 Federal and State funds to the Executive and Judicial 17 Departments for the fiscal year July 1, 2019, to June 30, 18 2020, and for the payment of bills incurred and remaining 19 20 unpaid at the close of the fiscal year ending June 30, 2019," 21 adding a Federal appropriation to the Department of Education 22 for the fiscal year July 1, 2020, to June 30, 2021.
