## AN ACT

- Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An
- act relating to the public school system, including certain
- provisions applicable as well to private and parochial
- schools; amending, revising, consolidating and changing the
- laws relating thereto," in preliminary provisions, providing for career information and recruitment.

- The General Assembly of the Commonwealth of Pennsylvania
- hereby enacts as follows: 8
- 9 Section 1. The act of March 10, 1949 (P.L.30, No.14), known
- as the Public School Code of 1949, is amended by adding a 10
- 11 section to read:
- 12 Section 128. Career Information and Recruitment. -- (a)
- Subject to subsection (c), a school entity shall offer 13
- 14 representatives of skilled trades, area vocational-technical
- 15 schools, community colleges operating under Article XIX-A,
- 16 institutions of higher education, business, industry, charitable
- 17 institutions and other employers with equal access to
- 18 participate in the following:
- 19 (1) Delivery of information regarding employment, employment

- 1 training or education opportunities to students enrolled in the
- 2 school entity.
- 3 (2) Recruitment of students enrolled in the school entity.
- 4 (b) Each school entity receiving assistance under the Every
- 5 Student Succeeds Act (Public Law 114-95, 129 Stat. 1802) shall
- 6 provide military recruiters the same access to students as
- 7 provided under subsection (a).
- 8 <u>(c) A school entity shall:</u>
- 9 (1) Provide each of the representatives under subsections
- 10 (a) and (b) with the following:
- 11 (i) Equal access to the school entity's employment,
- 12 placement or guidance services.
- 13 (ii) At least one opportunity during the school year to
- 14 provide age-appropriate information to all students in grades
- 15 four through twelve regarding educational opportunities,
- 16 employment training or career opportunities, individually or in
- 17 a group setting, through making a presentation at a school
- 18 assembly, hosting students for a visit to an area vocational-
- 19 technical school, community college, institution of higher
- 20 education or place of employment or any other method of speaking
- 21 directly to students.
- 22 (2) Document annually the following in the plan developed
- 23 under 22 Pa. Code § 339.31 (relating to plan):
- 24 (i) The school entity's compliance with this section for the
- 25 <u>immediately preceding school year.</u>
- 26 (ii) The school entity's plan to provide students with
- 27 <u>access to informational materials and career presenters as</u>
- 28 required under this section in the following school year.
- 29 (3) Post the plan on the school entity's publicly accessible
- 30 Internet website.

- 1 (d) A school entity may not discourage students from
- 2 pursuing any educational or career path and shall ensure that
- 3 <u>each student enrolled in the school entity has access to the</u>
- 4 <u>information and activities required to be provided under this</u>
- 5 section.
- 6 (e) The Department of Education, in collaboration with the
- 7 Department of Labor and Industry, shall develop standard
- 8 <u>informational materials which include, but are not limited to, a</u>
- 9 <u>summary of regional workforce needs, career cluster occupations,</u>
- 10 high-priority occupations, training opportunities and future
- 11 <u>earning potential</u>. The materials shall be reviewed and updated
- 12 <u>annually. Each school entity shall ensure such materials are</u>
- 13 <u>distributed to all students in grades four through twelve during</u>
- 14 the school year and are also made available at any scheduled
- 15 educational or career fair.
- 16 (f) As used in this section, the following words and phrases
- 17 shall have the meanings given to them in this subsection unless
- 18 the context clearly indicates otherwise:
- 19 "Institution of higher education." An accredited entity
- 20 which is any of the following:
- 21 (1) A university within the State System of Higher
- 22 Education.
- 23 (2) The Pennsylvania State University, the University of
- 24 Pittsburgh, Temple University, Lincoln University or any other
- 25 institution designated as State-related by the Commonwealth.
- 26 (3) The Thaddeus Stevens College of Technology.
- 27 (4) A college established under Article XIX-G.
- 28 (5) An institution of higher education located in and
- 29 incorporated or chartered by the Commonwealth and entitled to
- 30 confer degrees as specified in 24 Pa.C.S. § 6505 (relating to

- 1 power to confer degrees) and as provided for by the standards
- 2 and qualifications prescribed by the State Board of Education
- 3 under 24 Pa.C.S. Ch. 65 (relating to private colleges,
- 4 universities and seminaries).
- 5 (6) A private school licensed under the act of December 15,
- 6 1986 (P.L.1585, No.174), known as the Private Licensed Schools
- 7 Act.
- 8 (7) A foreign corporation approved to operate an educational
- 9 <u>enterprise under 22 Pa. Code Ch. 36 (relating to foreign</u>
- 10 corporation standards).
- "School entity." An area vocational-technical school, school
- 12 district, intermediate unit, cyber charter school, charter
- 13 school or regional charter school.
- 14 Section 2. This act shall take effect in 60 days.
