AN ACT

Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain provisions applicable as well to private and parochial 3 schools; amending, revising, consolidating and changing the 4 laws relating thereto," in preliminary provisions, providing for career information and recruitment. 6 7 The General Assembly of the Commonwealth of Pennsylvania 8 hereby enacts as follows: 9 Section 1. The act of March 10, 1949 (P.L.30, No.14), known 10 as the Public School Code of 1949, is amended by adding a 11 section to read: 12 Section 128. Career Information and Recruitment. -- (a) 13 Subject to subsection (c), a school entity shall offer 14 representatives of skilled trades, PUBLICLY IDENTIFIED PRIORITY <--15 OCCUPATIONS, area vocational-technical schools, community colleges operating under Article XIX-A- AND institutions of 16 higher education, business, industry, charitable institutions 17

- 1 and other employers with equal access to THE OPPORTUNITY TO
- 2 participate in the following:
- 3 (1) Delivery of information regarding employment, employment
- 4 training or education opportunities to students enrolled in the
- 5 school entity.
- 6 (2) Recruitment of students enrolled in the school entity.
- 7 (b) Each school entity receiving assistance under the Every
- 8 Student Succeeds Act (Public Law 114-95, 129 Stat. 1802) shall
- 9 provide military recruiters the same access to students as
- 10 provided under subsection (a).
- 11 (c) A school entity shall:
- 12 (1) Provide each of the representatives under subsections
- 13 (a) and (b) with the following:
- (i) Equal access to the school entity's employment,
- 15 placement or guidance services.
- 16 (ii) At least one opportunity during the school year to
- 17 provide age-appropriate information to all students in grades
- 18 four through twelve regarding educational opportunities,
- 19 employment training or career opportunities, individually or in
- 20 a group setting, through making a presentation at a school
- 21 assembly, hosting students for a visit to an area vocational-
- 22 technical school, community college, institution of higher
- 23 education or place of employment or any other method of speaking
- 24 directly to students.
- 25 (2) Document annually the following in the plan developed
- 26 under 22 Pa. Code § 339.31 (relating to plan):
- 27 <u>(i) The school entity's compliance with this section for the</u>
- 28 immediately preceding school year.
- 29 (ii) The school entity's plan to provide students with
- 30 <u>access to informational materials and career presenters as</u>

- 1 required under this section in the following school year.
- 2 (3) Post the plan on the school entity's publicly accessible
- 3 Internet website.
- 4 (d) A school entity may not discourage students from
- 5 pursuing any educational or career path and shall ensure that
- 6 <u>each student enrolled in the school entity has access to the</u>
- 7 information and activities required to be provided under this
- 8 <u>section.</u>
- 9 (e) The Department of Education, in collaboration with the
- 10 Department of Labor and Industry, shall develop standard
- 11 <u>informational materials which include</u>, but are not limited to, a
- 12 <u>summary of regional workforce needs PRODUCED BIENNIALLY BY THE</u> <--
- 13 <u>DEPARTMENT OF LABOR AND INDUSTRY, career cluster occupations,</u>
- 14 high priority PUBLICLY IDENTIFIED PRIORITY occupations, training <--
- 15 opportunities and future earning potential. The materials shall
- 16 be reviewed and updated annually. Each school entity shall
- 17 ensure such materials are distributed to THAT all students in <--
- 18 grades four through twelve ARE PROVIDED ACCESS TO THE MATERIALS <--
- 19 during the school year and are also made available at any
- 20 scheduled educational or career fair.
- 21 (f) As used in this section, the following words and phrases
- 22 shall have the meanings given to them in this subsection unless
- 23 the context clearly indicates otherwise:
- "Institution of higher education." An accredited entity
- 25 which is any of the following:
- 26 (1) A university within the State System of Higher Education

- 28 (2) The Pennsylvania State University, the University of
- 29 Pittsburgh, Temple University, Lincoln University or any other
- 30 institution designated as State-related by the Commonwealth.

- 1 (3) The Thaddeus Stevens College of Technology.
- 2 (4) A college established under Article XIX-G.
- 3 (5) An institution of higher education located in and
- 4 <u>incorporated or chartered by the Commonwealth and entitled to</u>
- 5 confer degrees as specified in 24 Pa.C.S. § 6505 (relating to
- 6 power to confer degrees) and as provided for by the standards
- 7 and qualifications prescribed by the State Board of Education
- 8 <u>under 24 Pa.C.S. Ch. 65 (relating to private colleges,</u>
- 9 <u>universities and seminaries</u>).
- 10 (6) A private school licensed under the act of December 15,
- 11 1986 (P.L.1585, No.174), known as the Private Licensed Schools
- 12 <u>Act.</u>
- 13 (7) A foreign corporation approved to operate an educational
- 14 <u>enterprise under 22 Pa. Code Ch. 36 (relating to foreign</u>
- 15 <u>corporation standards</u>).
- 16 "PUBLICLY IDENTIFIED PRIORITY OCCUPATION." A PROFESSION
- 17 THAT:
- 18 (1) IS HIGH-WAGE AND HIGH-SKILL FOR WHICH THERE IS EXCESS
- 19 EMPLOYER DEMAND AS MAY BE INCLUDED IN THE DEPARTMENT OF LABOR
- 20 AND INDUSTRY'S CURRENT YEAR'S HIGH-PRIORITY OR IN-DEMAND
- 21 OCCUPATIONS LIST OR THE STATE SYSTEM OF HIGHER EDUCATION'S
- 22 WORKFORCE NEEDS ASSESSMENT.
- 23 (2) REQUIRES A CREDENTIAL, CERTIFICATION, LICENSING,
- 24 POSTSECONDARY TRAINING, ASSOCIATE'S DEGREE, BACHELOR'S DEGREE,
- 25 MASTER'S DEGREE OR DOCTORAL OR FIRST PROFESSIONAL DEGREE.
- 26 "School entity." An area vocational-technical school, school
- 27 <u>district</u>, <u>intermediate unit</u>, <u>cyber charter school</u>, <u>charter</u>
- 28 school or regional charter school.
- 29 Section 2. This act shall take effect in 60 days.
