12	The General Assembly of the Commonwealth of Pennsylvania
13	hereby enacts as follows:
14	Section 1. The act of March 4, 1971 (P.L.6, No.2), known as
15	the Tax Reform Code of 1971, is amended by adding an article to

17	ARTICLE XVII-L
18	COMMUTER AND COMMERCE TOLL TAX CREDIT
19	Section 1701-L. Scope of article.
20	This article relates to the commuter and commerce toll tax
21	credits.
22	Section 1702-I. Definitions

- 1 The following words and phrases when used in this article
- 2 shall have the meanings given to them in this section unless the
- 3 context clearly indicates otherwise:
- 4 <u>"Department." The Department of Revenue of the Commonwealth.</u>
- 5 "Pass-through entity." Any of the following:
- 6 (1) A partnership, limited partnership, limited
- 7 <u>liability company, business trust or other unincorporated</u>
- 8 <u>entity that for Federal income tax purposes is taxable as a</u>
- 9 <u>partnership.</u>
- 10 (2) A Pennsylvania S corporation.
- "Qualified tax liability." For a taxpayer who is an
- 12 <u>individual</u>, taxes imposed under Article III and for all other
- 13 taxpayers, taxes imposed under Articles III, IV and VI. The term
- 14 shall include the liability for taxes imposed under Article III
- 15 <u>on a shareholder of a pass-through entity.</u>
- 16 "Qualified toll expense." Any remuneration paid through the
- 17 use of an E-Z Pass transponder or paid with cash or a credit or
- 18 debit card for access and use of the Pennsylvania Turnpike and
- 19 <u>all toll bridges operated under the Delaware River Joint Toll</u>
- 20 Bridge Commission, the Delaware River Port Authority of
- 21 Pennsylvania and New Jersey and the Burlington County Bridge
- 22 Commission.
- 23 "Tax credit." The Commuter and Commerce Toll Tax Credit
- 24 authorized under this article.
- 25 "Taxpayer." A Pennsylvania-based entity or individual
- 26 Pennsylvania resident subject to tax under Article III, IV or
- 27 <u>VI. The term shall include the shareholder, owner or member of a</u>
- 28 pass-through entity that receives a tax credit.
- 29 <u>Section 1703-L. Credit for qualified toll expense.</u>
- 30 (a) Application.--

- 1 (1) A taxpayer that incurs a qualified toll expense in a
- 2 <u>taxable year may apply for a tax credit as provided under</u>
- 3 this article. By September 15 of each year, a taxpayer must
- 4 <u>submit an application to the department for a qualified toll</u>
- 5 <u>expense incurred in the taxable year that ended in the prior</u>
- 6 <u>calendar year.</u>
- 7 (2) The taxpayer must include with the application a
- 8 receipt for each qualified toll expense that was paid with
- 9 <u>cash or a credit or debit card. Receipts shall not be</u>
- transferrable from one taxpayer to another for the purpose of
- 11 <u>submitting an application for a tax credit.</u>
- 12 (b) Receipt. -- A taxpayer that is qualified under subsection
- 13 (a) shall receive a tax credit for the taxable year in the
- 14 amount of 50%, not to exceed \$500, of the taxpayer's total
- 15 qualified toll expense for the taxable year.
- (c) Notification. -- By December 15 of the calendar year
- 17 following the close of the taxable year during which the
- 18 qualified toll expense was incurred, the department shall notify
- 19 the taxpayer of the amount of the taxpayer's tax credit approved
- 20 by the department.
- 21 Section 1704-L. Carryover, carryback, refund and assignment of
- 22 <u>credit</u>.
- 23 (a) Carryover.--If the taxpayer cannot use the entire amount
- 24 of the tax credit for the taxable year in which the tax credit
- 25 is first approved, the excess may be carried over succeeding
- 26 taxable years and used as a credit against the qualified tax
- 27 <u>liability of the taxpayer for those taxable years. Each time</u>
- 28 that the tax credit is carried over to a succeeding taxable
- 29 year, it is to be reduced by the amount that was used as a
- 30 credit during the immediately preceding taxable year. The tax

- 1 <u>credit provided by this article may be carried over and applied</u>
- 2 to succeeding taxable years for no more than 15 taxable years
- 3 <u>following the first taxable year for which the taxpayer was</u>
- 4 entitled to claim the credit.
- 5 (b) Application of tax credit. -- A tax credit approved by the
- 6 <u>department for a qualified toll expense in a taxable year first</u>
- 7 <u>shall be applied against the taxpayer's qualified tax liability</u>
- 8 for the current taxable year as of the date on which the credit
- 9 was approved before the tax credit is applied against any tax
- 10 <u>liability under subsection (a).</u>
- 11 (c) Carryback or refund. -- A taxpayer shall not be entitled
- 12 to carry back or obtain a refund of an unused tax credit.
- 13 <u>Section 1705-L. Limitation on credits.</u>
- 14 (a) Total amount.--The total amount of tax credits approved
- 15 by the department may not be limited in any fiscal year.
- 16 (b) Allocation. -- Tax credits to each taxpayer under this
- 17 article may not exceed \$500 annually.
- 18 Section 1706-L. Shareholder, owner or member pass-through.
- 19 <u>(a) Application to Pennsylvania S corporations.--If a</u>
- 20 Pennsylvania S corporation does not have an eligible tax
- 21 liability against which the tax credit may be applied, a
- 22 shareholder of the Pennsylvania S corporation shall be entitled
- 23 to a tax credit equal to the tax credit determined for the
- 24 Pennsylvania S corporation for the taxable year multiplied by
- 25 the percentage of the Pennsylvania S corporation's distributive
- 26 income to which the shareholder is entitled.
- 27 (b) Other applications. -- If a pass-through entity other than
- 28 a Pennsylvania S corporation does not have an eligible tax
- 29 liability against which the tax credit may be applied, an owner
- 30 or member of the pass-through entity shall be entitled to a tax

- 1 credit equal to the tax credit determined for the pass-through
- 2 entity for the taxable year multiplied by the percentage of the
- 3 pass-through entity's distributive income to which the owner or
- 4 member is entitled.
- 5 (c) Additional credit. -- The credit provided under subsection
- 6 (a) or (b) shall be in addition to any tax credit to which a
- 7 <u>shareholder</u>, <u>owner or member of a pass-through entity is</u>
- 8 otherwise entitled under this article, except that a pass-
- 9 through entity and a shareholder, owner or member of a pass-
- 10 through entity may not claim a credit under this article for the
- 11 <u>same qualified toll expense.</u>
- 12 <u>Section 1707-L. Regulations.</u>
- 13 The department shall promulgate regulations necessary for the
- 14 <u>implementation and administration of this article.</u>
- 15 Section 2. The addition of Article XVII-L of the act shall
- 16 apply to taxable years beginning after December 31, 2019.
- 17 Section 3. This act shall take effect in 60 days.
