AN ACT

- 1 Designating the bridge located over Washington's Landing and the
- 2 Allegheny River, commonly known as the 31st Street Bridge, in
- the City of Pittsburgh, Allegheny County, as the William
- 4 Raymond Prom Memorial Bridge.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. William Raymond Prom Memorial Bridge.
- 8 (a) Declaration of policy. -- The General Assembly finds and
- 9 declares as follows:
- 10 (1) William Raymond Prom (Billy) was born November 17th,
- 11 1948, in Pittsburgh, Pennsylvania, to parents Finbola Prom
- and Fred Charles Prom. He grew up with his brother, Fred
- 13 Charles Prom, Jr., and sister, Clara Prom, in Reserve
- 14 Township and attended Mt. Troy Public School and Millvale
- 15 High School. Billy was affectionately known by so many
- 16 throughout his life as Butch.
- 17 (2) William Prom enlisted in the United States Marine
- 18 Corps Reserve on December 8, 1967, and was discharged to
- enlist in the regular Marine Corps on December 27, 1967.

- 1 William Prom started his tour of duty in the Vietnam War on
- 2 Thursday, June 13, 1968, at 20 years of age. Upon completion
- 3 of recruit training with the 3rd Recruit Training Battalion,
- 4 Marine Corps Recruit Depot on Parris Island in South
- 5 Carolina, he was promoted to private first class on March 1,
- 6 1968. He was transferred to the Marine Corps Base at Camp
- 7 Lejeune in North Carolina and underwent individual combat
- 8 training with the 2nd Infantry Training Regiment and Weapons
- 9 Special Training with the 1st Battalion, 1st Infantry
- 10 Training Regiment.
- 11 (3) In June 1968, William Prom arrived in the Republic
- of Vietnam where he served consecutively as ammunition man,
- assistant gunner, machine gun team leader and machine gun
- 14 squad leader with Company I, 3rd Battalion, 3rd Marines, 3rd
- Marine Division. He was promoted to Lance Corporal on
- 16 September 1, 1968.
- 17 (4) While participating in Operation Taylor Common,
- during a reconnaissance in-force operation southwest of An
- 19 Hoa on February 9, 1969, William Prom was returning from the
- operation along with two platoons when Company I came under
- an intense automatic weapons fire and grenade attack from a
- 22 well-concealed North Vietnamese Army force in fortified
- positions. The leading element of the platoon was isolated
- and several marines were wounded. Lance Corporal Prom
- 25 immediately assumed control of one of his machine guns and
- 26 began to deliver return fire. Disregarding his safety he
- 27 advanced to a position from which he could more effectively
- deliver covering fire while first aid was being administered
- 29 to the wounded men. Realizing that the enemy would have to be
- 30 destroyed before the injured marines could be evacuated,

- 1 Lance Corporal Prom again moved forward and delivered a heavy
- 2 volume of fire with such accuracy that he was instrumental in
- 3 overpowering the enemy, thus permitting his men to regroup
- 4 and resume their march. Shortly thereafter, the platoon again
- 5 came under fire in which a marine was critically wounded.
- 6 Reacting instantly, Lance Corporal Prom moved forward to
- 7 protect his injured comrade. Unable to continue his fire
- 8 because of his own severe wounds, he continued to advance to
- 9 within a few yards of the enemy positions. There, standing in
- 10 full view of the enemy, he accurately directed the fire of
- 11 his support elements until he was mortally wounded. Inspired
- 12 by his heroic actions the marines launched an assault that
- destroyed the enemy. Lance Corporal Prom's unconquerable
- 14 courage, inspiring initiative and selfless devotion to duty
- upheld the highest traditions of the Marine Corps and the
- naval service of the United States. He gallantly gave his
- 17 life for his country.
- 18 (5) Thanks to his exemplary service he was awarded the
- 19 Medal of Honor, the Purple Heart, the National Defense
- 20 Service Medal, the Vietnam Service Medal and the Republic of
- 21 Vietnam Campaign Medal.
- 22 (b) Designation. -- The bridge located over Washington's
- 23 Landing and the Allegheny River, commonly known as the 31st
- 24 Street Bridge in the City of Pittsburgh, Allegheny County, is
- 25 hereby designated as the William Raymond Prom Memorial Bridge.
- 26 (c) Signs.--The Department of Transportation shall erect and
- 27 maintain appropriate signs displaying the name of the bridge to
- 28 traffic in both directions on the bridge.
- 29 Section 2. Effective date.
- 30 This act shall take effect in 60 days.
