- 6 Section 1. The following separate and distinct amendments to
- 7 the Constitution of Pennsylvania are proposed in accordance with
- 8 Article XI:
- 9 That Article I be amended by adding a section to read:
- 10 § 30. Economic bill of rights.
- 11 (a) The people shall have the right to a living wage to
- reasonably support one's self and their family. 12
- 13 (b) The people shall have the right to affordable and
- 14 accessible health care and the opportunity to achieve and enjoy
- 15 good physical and mental health.
- 16 (c) The people shall have the right to safe, efficient and
- reliable transportation infrastructure. 17
- (d) The people shall have the right to safe and healthy 18

- 1 working conditions.
- 2 Section 2. The following procedure applies to the proposed
- 3 constitutional amendments in this joint resolution:
- 4 (1) Upon the first passage by the General Assembly of
 5 the amendments, the Secretary of the Commonwealth shall
 6 proceed immediately to comply with the advertising
- 7 requirements of section 1 of Article XI of the Constitution
- 8 of Pennsylvania.

- 9 (2) Upon the second passage by the General Assembly of
 10 the amendments, the Secretary of the Commonwealth shall
 11 proceed immediately to comply with the advertising
 12 requirements of section 1 of Article XI of the Constitution
 13 of Pennsylvania. The Secretary of the Commonwealth shall:
 - (i) Submit the amendment under section 1 of this resolution adding section 30(a) to Article I of the Constitution of Pennsylvania to the qualified electors of this Commonwealth as a separate ballot question at the first primary, general or municipal election which meets the requirements of section 1 of Article XI of the Constitution of Pennsylvania.
 - (ii) Submit the amendment under section 1 of this resolution adding section 30(b) to Article I of the Constitution of Pennsylvania to the qualified electors of this Commonwealth as a separate ballot question at the first primary, general or municipal election which meets the requirements of section 1 of Article XI of the Constitution of Pennsylvania.
 - (iii) Submit the amendment under section 1 of this resolution adding section 30(c) to Article I of the Constitution of Pennsylvania to the qualified electors of

this Commonwealth as a separate ballot question at the first primary, general or municipal election which meets the requirements of section 1 of Article XI of the Constitution of Pennsylvania.
