## AN ACT

- 1 Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An
- act relating to the public school system, including certain
  - provisions applicable as well to private and parochial
- schools; amending, revising, consolidating and changing the
- laws relating thereto," in high schools, further providing
- for courses of study.
- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 Section 1. Section 1605 of the act of March 10, 1949
- 10 (P.L.30, No.14), known as the Public School Code of 1949, is
- 11 amended by adding a subsection to read:
- 12 Section 1605. Courses of Study.--\* \* \*
- 13 (d) (1) Beginning with students graduating from a public
- 14 high school at the end of the 2020-2021 school year, and
- 15 continuing in each school year thereafter, a student who
- 16 <u>successfully completes a course in personal finance during</u>
- 17 grades nine through twelve shall be permitted to apply up to one
- 18 credit earned for successful completion of the course to satisfy

- 1 the student's social studies, family and consumer science,
- 2 <u>mathematics or business education credit requirement for</u>
- 3 graduation, provided that the governing body of the student's
- 4 <u>public high school shall have discretion to determine the</u>
- 5 graduation credit requirement to which the credit earned by the
- 6 <u>student shall be applied.</u>
- 7 (2) A STUDENT SHALL NOT BE PERMITTED TO APPLY MORE THAN ONE <--
- 8 CREDIT EARNED UNDER SUBSECTIONS (C) AND (D) TO SATISFY THE
- 9 <u>STUDENT'S MATHEMATICS CREDIT REQUIREMENT FOR GRADUATION.</u>
- 10 (3) As used in this subsection, the following words and <--
- 11 phrases shall have the meanings given to them in this paragraph
- 12 unless the context clearly indicates otherwise:
- 13 <u>"Personal finance" shall mean the integration of various</u>
- 14 <u>factors relating to personal financial management, including</u>
- 15 understanding financial institutions, using money, learning to
- 16 manage personal assets and liabilities, creating budgets and any
- 17 other factors that may assist an individual in this Commonwealth
- 18 to be financially responsible.
- 19 "Public high school" shall mean a public school, including a
- 20 school within a school district, a charter school, a cyber
- 21 charter school, a regional charter school or a career and
- 22 technical school, that offers twelfth grade.
- 23 Section 2. This act shall take effect in 60 days.
