AN ACT

- 1 Amending Title 18 (Crimes and Offenses) of the Pennsylvania
- 2 Consolidated Statutes, in dissemination of criminal history
- record information, further providing for use of records for
- 4 employment.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Section 9125 of Title 18 of the Pennsylvania
- 8 Consolidated Statutes is amended to read:
- 9 § 9125. Use of records for employment.
- 10 (a) General rule. -- Whenever an employer is in receipt of
- 11 information which is part of [an employment applicant's] an
- 12 <u>individual's</u> criminal history record information file, it may
- 13 use that information for the purpose of [deciding whether or not
- 14 to hire the applicant] taking an adverse employment action, only
- 15 in accordance with this section.
- 16 (b) Use of information. -- Felony and misdemeanor convictions
- 17 may be considered by the employer only to the extent to which
- 18 they relate to the [applicant's] individual's suitability for
- 19 employment in the position [for which he has applied.

- 1 (c) Notice. -- The employer shall notify in writing the
- 2 applicant if the decision not to hire the applicant is based in
- 3 whole or in part on criminal history record information.]:
- 4 (1) for which the individual has applied; or
- 5 (2) in which the individual is currently employed.
- 6 (d) Exceptions. -- Notwithstanding subsection (b), an employer
- 7 may not inquire about or consider the following when determining
- 8 <u>an individual's suitability for employment:</u>
- 9 <u>(1) A case with a final disposition that is not a</u>
- 10 conviction.
- 11 (2) A juvenile case resulting in an adjudication of
- 12 <u>delinquency</u>.
- 13 (3) A conviction of a summary offense.
- 14 <u>(4) A case that was expunged or pardoned.</u>
- 15 (e) Initial considerations. -- When determining an
- 16 individual's suitability for employment, if the individual has
- 17 been convicted of a felony or misdemeanor, the employer must
- 18 consider the following information:
- 19 (1) The nature of the crime.
- 20 (2) The time that has passed since the offense or
- completion of the sentence. An offense may only be considered
- 22 within seven years of the date of arrest or date of release
- from incarceration, whichever is later.
- 24 (3) The type of employment sought or currently held.
- 25 (f) Notice.--If the employer initially determines that an
- 26 individual is not suitable for employment after evaluating the
- 27 <u>considerations under subsection (e), the employer must provide</u>
- 28 the individual with a copy of the criminal record information on
- 29 which it is relying at least seven days prior to making a final
- 30 decision.

1	(g) Final considerations Prior to making a final decision
2	on the individual's suitability for employment, the employer
3	must consider any information provided by the individual related
4	to the following:
5	(1) The accuracy of the criminal record information.
6	(2) The individual's employment history before or after
7	the offense.
8	(3) The individual's performance in the position or a
9	similar position.
0 .	(4) Employment or character references.
1	(5) Evidence of rehabilitation.
2	(6) Other information that may demonstrate the
13	individual is suitable for employment in the position.
4	(h) Powers and duties of department The department shall:
_5	(1) Enforce and administer the provisions of this
- 6	section. The department may promulgate regulations necessary
_7	to implement this section.
8 ـ	(2) Investigate credible complaints made to the
9	department alleging a violation of this section. The
20	following shall apply:
21	(i) The department shall have subpoena power.
22	Application may be made to the Commonwealth Court to
23	enforce a subpoena. Nothing in this subparagraph shall be
24	construed to excuse an individual from producing
25	documents and records as requested by the department
26	under another provision of law.
27	(ii) The department shall provide a written
28	determination at the conclusion of the investigation
29	explaining the department's conclusion as to whether a
30	violation of this section has occurred.

1	<u>(i) Retaliation prohibited</u>
2	(1) An employer may not:
3	(i) interfere with, restrain or deny the exercise of
4	rights provided under this section; or
5	(ii) discharge, discriminate or take adverse action
6	in retaliation for exercising rights protected under this
7	section. Rights protected under this section include:
8	(A) making a complaint to or informing the
9	department of an employer's noncompliance with this
10	section;
11	(B) participating in investigations or
12	proceedings; and
13	(C) informing an individual of the individual's
14	potential rights and assisting the individual in
15	asserting the rights.
16	(2) If an employer takes adverse action against an
17	individual within 90 days of the individual's exercise of
18	rights protected under this section, the act shall raise a
19	rebuttable presumption of the employer's having done so in
20	retaliation for the individual exercising rights protected
21	under this section.
22	(j) Administrative penalties The following shall apply:
23	(1) The department shall assess the following penalties
24	on an employer that violates this section or a regulation
25	<pre>promulgated under this section:</pre>
26	(i) For a first offense, a fine of not less than
27	\$1,000 nor more than \$2,500 for each violation of this
28	section.
29	(ii) For a second or subsequent offense, a fine of
30	not less than \$2,500 nor more than \$5,000 for each

1	violation of this section.
2	(2) The department may order an employer to take any
3	action which the department deems necessary to correct a
4	violation of this section.
5	(3) An action by the department under this subsection
6	shall be subject to review under 2 Pa.C.S. Chs. 5 Subch. A
7	(relating to practice and procedure of Commonwealth agencies)
8	and 7 Subch. A (relating to judicial review of Commonwealth
9	agency action).
10	(k) Civil penalties The department or an individual who in
11	good faith alleges a violation of this section may institute an
12	action in a court of competent jurisdiction against an employer.
13	An action alleging retaliation must be instituted within two
14	years from the date the alleged retaliation occurred. All other
15	actions alleging a violation of this section must be instituted
16	within one year of the alleged violation. An action under this
17	subsection may request any of the following:
18	(1) Back pay.
19	(2) Compensatory damages.
20	(3) Punitive damages.
21	(4) Reasonable attorney fees and costs of litigation.
22	(5) Any other relief that the court deems appropriate,
23	including instatement or reinstatement to an employment
24	position.
25	(1) Applicability
26	(1) This section shall apply if a Federal law or other
27	State law does not preclude, based on criminal history record
28	information, an individual from an employment position.
29	(2) This section shall not apply if a Federal law or

other State law precludes, based on criminal history record

- 1 <u>information</u>, an individual from an employment position.
- 2 (m) Definitions. -- As used in this section, the following
- 3 words and phrases shall have the meanings given to them in this
- 4 <u>subsection unless the context clearly indicates otherwise:</u>
- 5 "Department." The Department of Labor and Industry of the
- 6 <u>Commonwealth.</u>
- 7 "Individual." A job applicant, employee or contractor.
- 8 Section 2. This act shall take effect in 90 days.
