## AN ACT

- 1 Amending the act of June 13, 1967 (P.L.31, No.21), entitled "An
- act to consolidate, editorially revise, and codify the public
- welfare laws of the Commonwealth," further providing for
- 4 verification of eligibility.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Section 441.9 of the act of June 13, 1967
- 8 (P.L.31, No.21), known as the Public Welfare Code, added July 7,
- 9 2005 (P.L.177, No.42), is amended to read:
- 10 Section 441.9. Verification of Eligibility. -- (a) Except as
- 11 set forth in subsection (b), income shall be verified prior to
- 12 authorization of medical assistance or during a redetermination
- 13 of a recipient's eligibility unless the verification is pending
- 14 from a third party and the applicant has cooperated in the
- 15 verification attempt in accordance with department regulations.
- 16 (b) Notwithstanding subsection (a), the department may

- 1 authorize medical assistance for pregnant women, children, the
- 2 elderly or people with disabilities if third-party, automated
- 3 sources of verification are used to verify income within sixty
- 4 days of the date of authorization.
- 5 (c) Except as prohibited by Federal law, it shall be a
- 6 condition of eligibility for medical assistance that an
- 7 applicant or recipient consent to the disclosure of information
- 8 about the age, residence, citizenship, employment, applications
- 9 for employment, income and resources of the applicant or
- 10 recipient which is in the possession of third parties. Consent
- 11 shall be effective to authorize a third party to release
- 12 information requested by the department. Except in a case of
- 13 suspected fraud, the department shall attempt to notify the
- 14 applicant or recipient prior to contacting a third party for
- 15 information about the applicant or recipient.
- 16 (d) All applicants and recipients shall, as a condition of
- 17 <u>eligibility, pursue COOPERATE WITH THE DEPARTMENT IN SECURING</u>

- 18 medical support from the noncustodial parent of any child for
- 19 whom medical assistance is sought OR PROVIDED.
- 20 Section 2. This act shall take effect in 60 days.
