Amending the act of March 4, 1971 (P.L.6, No.2), entitled "An act relating to tax reform and State taxation by codifying and enumerating certain subjects of taxation and imposing taxes thereon; providing procedures for the payment, 3 4 collection, administration and enforcement thereof; providing for tax credits in certain cases; conferring powers and 7 imposing duties upon the Department of Revenue, certain employers, fiduciaries, individuals, persons, corporations 8 and other entities; prescribing crimes, offenses and 9 penalties," further providing for declarations of estimated 10 11 The General Assembly of the Commonwealth of Pennsylvania 12 13 hereby enacts as follows: 14 Section 1. Section 325(d) of the act of March 4, 1971 (P.L.6, No.2), known as the Tax Reform Code of 1971, amended May 15 16 12, 1999 (P.L.26, No.4), is amended to read: 17 Section 325. Declarations of Estimated Tax.--* * * 18 Except as hereinafter provided, the date for filing a declaration of estimated tax shall depend upon when the resident 19

- 1 or its income on which no tax has been withheld under this
- 2 article can reasonably be expected to exceed [eight thousand
- 3 dollars (\$8,000)] twenty thousand dollars (\$20,000) in the

- 5 (1) If the determination is made on or before April 1 of the
- 6 taxable year, a declaration of estimated tax shall be filed no
- 7 later than April 15 of the taxable year.
- 8 (2) If the determination is made after April 1 but before
- 9 June 2 of the taxable year, the declaration shall be filed no
- 10 later than June 15 of such year.
- 11 (3) If the determination is made after June 1 but before
- 12 September 2 of the taxable year, the declaration shall be filed
- 13 no later than September 15 of such year.
- 14 (4) If the determination is made after September 1 of the
- 15 taxable year, the declaration shall be filed no later than
- 16 January 15 of the year succeeding the taxable year.
