AN ACT

- 1 Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An
- act relating to the public school system, including certain
- provisions applicable as well to private and parochial
- schools; amending, revising, consolidating and changing the
- laws relating thereto," in preliminary provisions, further
- 6 providing for publication of notices and proofs of
- 7 publication.
- 8 The General Assembly of the Commonwealth of Pennsylvania
- 9 hereby enacts as follows:
- 10 Section 1. Section 106 of the act of March 10, 1949 (P.L.30,
- 11 No.14), known as the Public School Code of 1949, is amended to
- 12 read:
- 13 Section 106. Publication of Notices, etc.; Proofs of
- 14 Publication. -- (a) Whenever, under the provisions of this act,
- 15 notice is required to be published in one newspaper, such
- 16 publication shall be made <u>as follows:</u>
- 17 <u>(1)</u> in a newspaper of general circulation [as defined by the
- 18 "Newspaper Advertising Act" of May sixteen, one thousand nine
- 19 hundred twenty-nine (Pamphlet Laws 1784), printed in the county,
- 20 unless the matter in connection with which the advertising is

- 1 being done affects only a school district, in which case such
- 2 advertisement shall be published in a newspaper printed in such
- 3 school district, if there is such a newspaper, and if not, then
- 4 in a newspaper circulating generally in such school district. If
- 5 such notice is required to be published in more than one
- 6 newspaper, it shall be published in at least one newspaper of
- 7 general circulation, defined as aforesaid, printed, if there be
- 8 such a newspaper, or circulating generally, as above provided,
- 9 in the school district.
- 10 (b) When such notice relates to any proceeding or matter in
- 11 any court, or the holding of an election for the increase of
- 12 indebtedness, or the issue and sale of bonds to be paid by
- 13 taxation, such notice, in each school district, shall also be
- 14 published in the legal newspaper, if any, designated by the
- 15 rules of court of the proper county for the publication of legal
- 16 notices and advertisements: Provided, That auditors' statements,
- 17 summaries of auditors' statements, advertisements inviting
- 18 proposals for public contracts and for bids for materials and
- 19 supplies, or lists of delinquent taxpayers, shall be published
- 20 only in newspapers of general circulation, defined as
- 21 aforesaid.] in which the school district is located;
- 22 (2) in a legal newspaper designated by the rules of court of
- 23 the county in which the school district is located for the
- 24 publication of legal notices and advertisements;
- 25 (3) on the official, public Internet website of a newspaper
- 26 listed in paragraph (1) or (2), using HTML format or an
- 27 <u>equivalent language format; or</u>
- 28 <u>(4) in a locally circulated printed publication that is at</u>
- 29 <u>least four pages long</u>, is issued on at least a weekly basis and
- 30 is distributed by audited carriers to all known addresses within

- 1 <u>a political subdivision.</u>
- 2 (b.1) If notice is required to be published in more than one
- 3 <u>publication</u>, the <u>publication</u> shall be made by at least two of
- 4 the means of publication listed in subsection (a).
- 5 (b.2) A school district may determine the appropriate means
- 6 of publication from the means of publication listed in
- 7 subsection (a).
- 8 (b.3) Before a school district changes the manner in which
- 9 the school district publishes notices as required under this
- 10 act, the school district shall publish on its official, public
- 11 <u>Internet website a timely notice of the change in manner of</u>
- 12 <u>publication</u>.
- 13 (b.4) A school district shall maintain a permanent record of
- 14 <u>notices published on the school district's official, public</u>
- 15 Internet website. The record shall include the text, manner,
- 16 <u>date and duration of publication of each notice.</u>
- 17 (c) Proof of publication of any notice required to be given
- 18 by the posting of handbills or statements shall be made by
- 19 attaching an original copy of such handbill or statement as
- 20 actually printed and posted to an affidavit made by the person
- 21 posting such notice. Such affiant shall not be an interested
- 22 party or an employe of any person or persons interested in the
- 23 subject matter of said notice. His affidavit shall state where
- 24 and when the notices were posted and [where] the manner in which
- 25 the notice was published [in newspapers, as aforesaid]. A
- 26 printed copy, exactly as published [in said newspaper], shall be
- 27 securely attached to a similar affidavit of the publisher or his
- 28 designated agent.
- 29 Section 2. This act shall take effect immediately.
