AN ACT

- 1 Establishing the Child Care Health Consultant Task Force and 2 providing for its powers and duties.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Short title.
- 6 This act shall be known and may be cited as the Child Care
- 7 Health Consultant Task Force Act.
- 8 Section 2. Legislative findings.
- 9 The General Assembly finds and declares as follows:
- 10 (1) On any given day about 360,000 children are in some
- form of child day care in this Commonwealth. A great deal of
- 12 attention has been focused at both the national and State
- 13 level on preparing young children to enter school ready to
- learn. Research indicates that early childhood development
- 15 programs and child day-care programs can contribute to that
- 16 goal and can positively impact the intellectual, social,
- emotional and physical development of children.

- 1 (2) Physical health has also been shown to be an
- 2 indicator of children's ability to learn. It is widely known
- 3 that children who are not physically healthy are more likely
- 4 to have difficulty learning due to frequent absences,
- 5 illnesses and distractions.
- 6 (3) One strategy to address the health and safety needs
- of young children in child day-care programs is to provide
- 8 technical assistance to child day-care providers through the
- 9 use of child care health consultants who have expertise in
- 10 best practices relating to children's health and safety in
- 11 child day-care programs. Currently, 33 states have programs
- whereby nurses or other health care professionals assist
- child day-care programs in improving the health and safety of
- 14 children in these programs.
- 15 Section 3. Definitions.
- 16 The following words and phrases when used in this act shall
- 17 have the meanings given to them in this section unless the
- 18 context clearly indicates otherwise:
- "Child care health consultant." An individual who is
- 20 currently licensed or certified in a related health profession
- 21 who has knowledge in pediatrics and developmentally appropriate
- 22 health and safety practices for children and who assists a child
- 23 day-care provider in recognizing and promoting the health and
- 24 safety of children.
- 25 "Child day care." Care in lieu of parental care given for
- 26 part of the 24-hour day to children under 16 years of age, away
- 27 from the child's home. The term does not include care in lieu of
- 28 parental care given to a child under 16 years of age in a place
- 29 of worship during religious services.
- "Child day-care center." Any premises in which child day

- 1 care is provided simultaneously for seven or more children who
- 2 are not relatives of the provider and is subject to regulation
- 3 by the Department of Public Welfare.
- 4 "Child day-care provider." A child day-care center or family
- 5 day-care home.
- 6 "Department." The Department of Public Welfare of the
- 7 Commonwealth.
- 8 "Family day-care home." A home in which child day care is
- 9 provided at any one time to four, five or six children who are
- 10 not relatives of the provider of the child day care and which is
- 11 required to be registered under the act of June 13, 1967
- 12 (P.L.31, No.21), known as the Public Welfare Code.
- 13 "Task force." The Child Care Health Consultant Task Force.
- 14 Section 4. Establishment of task force.
- 15 The Child Care Health Consultant Task Force is established
- 16 within the department.
- 17 Section 5. Purpose of the task force.
- 18 The purpose of the task force is to advise the department,
- 19 the Governor and the General Assembly on the feasibility of
- 20 establishing a coordinated network of child care health
- 21 consultants to assist child day-care providers in recognizing
- 22 and promoting the health and safety of children in child day-
- 23 care centers and family day-care homes.
- 24 Section 6. Members of task force.
- 25 (a) Members.--Members of the task force shall be appointed
- 26 by the department within 30 days following the effective date of
- 27 this act. The task force shall consist of at least nine
- 28 individuals with expertise in child day care or child health
- 29 care. The task force must include representation from the
- 30 following:

- 1 (1) A Statewide association of child day-care providers.
- 2 (2) A Statewide association of family day-care home
- 3 providers.
- 4 (3) The department.
- 5 (4) The Department of Health of the Commonwealth.
- 6 (5) A State organization dealing with standards and
- 7 accreditation of child day-care programs.
- 8 (6) A State association representing pediatricians.
- 9 (7) A State association representing nurses.
- 10 (8) A State association representing children with
- 11 special needs.
- 12 (9) A parent or relative of a child who has recently
- 13 received or is currently receiving services in a child day-
- 14 care center or family day-care home.
- 15 (b) Chair.--The department shall appoint a member of the
- 16 task force to chair the task force.
- 17 Section 7. Meetings of the task force and technical support.
- 18 (a) Meetings.--The department, in consultation with task
- 19 force members, shall prepare a schedule of meetings so that the
- 20 task force can fulfill its duties within the time frame
- 21 established by this act.
- 22 (b) Staff.--The department shall provide sufficient staff to
- 23 enable the task force to complete its duties under this act.
- 24 (c) Expenses.--Members shall not receive compensation but
- 25 shall be reimbursed for expenses incurred in service of the task
- 26 force.
- 27 (d) Participation. -- A member not physically present may
- 28 participate by teleconference.
- 29 (e) Voting. -- Actions of the task force must be approved by a
- 30 majority of the members of the task force.

- 1 Section 8. Report.
- 2 (a) Submission. -- Within nine months after being convened by
- 3 the department, the task force shall submit a report to the
- 4 Governor, the General Assembly and the department with findings
- 5 and recommendations regarding the development of a network of
- 6 child care health consultants in this Commonwealth that will
- 7 assist child day-care providers through a coordinated program of
- 8 resources and supports.
- 9 (b) Contents of the report.--The report, at a minimum, shall
- 10 include:
- 11 (1) A summary of any existing programs, funding, laws
- and regulations in this Commonwealth relevant to development
- of a network of child care health consultants.
- 14 (2) A review of other state laws, regulations and
- programs that promote the use of child care health care
- 16 consultants and any Federal laws or programs related to
- 17 linking health care consultants to child care programs.
- 18 (3) Where information is available, a description of the
- 19 benefits of the use of child care health consultants in this
- 20 Commonwealth and in other states and possible benefits in
- 21 this Commonwealth of a network of child care health
- 22 consultants.
- 23 (4) A description of costs associated with arranging for
- 24 child care health consultants and possible use of Federal and
- 25 State funding for this purpose.
- 26 (5) Clarification of qualifications and categories of
- 27 health care practitioners who could qualify as child care
- 28 health consultants.
- 29 (6) A description of knowledge and skills necessary to
- 30 perform as a child care health consultant and how that can be

- 1 achieved.
- 2 (7) Recommendations relating to a plan for implementing
- 3 a child care health consultant program in this Commonwealth.
- 4 Section 9. Expiration.
- 5 This act shall expire one year following the effective date
- 6 of this act.
- 7 Section 10. Effective date.
- 8 This act shall take effect in 60 days.
