AN ACT

- Authorizing the transfer of title for certain Project 70 lands owned by Lehigh County to Whitehall Township, Lehigh County.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Lands to be transferred to Whitehall Township,
- 6 Lehigh County.
- 7 (a) Authorization. -- Under the requirements of section 20(b)
- 8 of the act of June 22, 1964 (Sp.Sess., P.L.131, No.8), known as
- 9 the Project 70 Land Acquisition and Borrowing Act, the General
- 10 Assembly hereby authorizes the transfer of the title for a
- 11 portion of the Project 70 lands owned by Lehigh County, known as
- 12 the Jordan Creek Parkway, which are more particularly described
- 13 in subsection (c), to Whitehall Township, Lehigh County.
- 14 (b) Project 70 restrictions. -- The lands described in
- 15 subsection (c) shall be transferred with all existing
- 16 restrictions currently imposed by the Project 70 Land
- 17 Acquisition and Borrowing Act upon conveyance of the lands to

- 1 Whitehall Township, Lehigh County.
- 2 (c) Property description. -- The parcels of land to be
- 3 transferred with existing Project 70 restrictions are located in
- 4 Whitehall Township, Lehigh County, and are more particularly
- 5 bounded and described as follows:
- 6 (1) Parcel 45.
- 7 All that certain tract of land located along Jordan Creek North
- 8 of Pennsylvania State Highway (U.S. Route 22, L.R. 771) in the
- 9 second ward of the Township of Whitehall, County of Lehigh and
- 10 Commonwealth of Pennsylvania, being bounded and described as
- 11 follows:
- 12 BEGINNING at a point in the line dividing lands now or late of
- 13 Michael Puchyr and Mary Puchyr, husband and wife, and D.S.
- 14 Sausman Enterprises, Inc., and in the northern right-of-way line
- 15 of Pennsylvania State Highway (U.S. Route 22, L.R. 771), thence
- 16 along said right-of-way line south 72 degrees 02 minutes 55
- 17 seconds West, 261.96 feet, crossing Jordan Creek to a point,

- 3 thence in and through land now or late of Michael Puchyr and
- 4 Mary Puchyr, husband and wife, the four (4) following courses

- 22 All that certain tract of land located in the second ward of the
- 23 Township of Whitehall, County of Lehigh and Commonwealth of
- 24 Pennsylvania, being bounded and described as follows, to wit:
- 25 BEGINNING at a point in the southern line of land now or late of
- 26 R.L. Hunsicker and in the eastern line of Mickley Road (T 862
- 27 thirty-three feet wide) thence along the southern line of land
- 28 now or late of R.L. Hunsicker South 68 degrees 53 minutes 50
- 29 seconds East, 164.40 feet to a point, thence in Jordan Creek and
- 30 along land now or late of Richard J. Deppe South 1 degree 09

- 15 feet to a point, and
- 16 2. North 77 degrees 25 minutes 05 seconds West, 194.73
- 17 feet to a point,
- 18 thence in and through land now or late of Horace W. McCready and
- 19 Ruth A. McCready, husband and wife, and along the eastern side
- 20 of Mickley Road (T862) the eight (8) following courses and
- 21 distances:

- 2. By a curve to the right with a radius of 823.03 feet

- 9 (d) Existing restrictions. -- The following restrictions shall
- 10 remain in the deeds of conveyance for the lands described in
- 11 subsection (c):
- 12 This indenture is given to provide land for recreation,
- conservation and historical purposes, as said purposes
- are defined in the act of June 22, 1964 (Sp.Sess.,
- P.L.131, No.8), known as the Project 70 Land Acquisition
- and Borrowing Act.
- 17 Section 2. Effective date.
- 18 This act shall take effect immediately.
