## AN ACT

Amending Title 75 (Vehicles) of the Pennsylvania Consolidated 1 Statutes, in licensing of drivers, further providing for duplicate and substitute drivers' licenses and learners' 2 3 permits; and, in fees, further providing for exemption of persons, entities and vehicles from fees. 5 6 The General Assembly of the Commonwealth of Pennsylvania 7 hereby enacts as follows: 8 Section 1. Sections 1513 heading and 1901(b.1) of Title 75 of the Pennsylvania Consolidated Statutes are amended and the sections are amended by adding subsections to read: 10 11 § 1513. Duplicate and substitute drivers' licenses [and],\_ 12 learners' permits and identification cards. 13 (c) Duplicate identification card fees. -- No fee shall be 14 15 charged for one duplicate identification card, including for a photograph required for a duplicate identification card, during 16 the term of either an initial or renewal identification card to 17 an individual exempt from fees under section 1901(b.1) (relating 18

- 10 (i) earning a household income equal to or less than

- 14 <u>(ii)</u> homeless, as defined on the effective date of
- this subsection in section 103 of the McKinney-Vento
- 16 Homeless Assistance Act (Public Law 100-77, 42 U.S.C. §
- 17 11302);
- 18 (2) a resident of this Commonwealth; and
- 19 (3) aware of the prohibitions on unsworn falsification
- to authorities set forth in 18 Pa.C.S. § 4904 (relating to
- 21 unsworn falsification to authorities).
- 22 (b.2) Initial identification card fees. -- Notwithstanding
- 23 subsection (b.1), no fee shall be charged for an initial
- 24 identification card, including for a photograph required for an
- 25 initial identification card, to an individual who is 18 years of
- 26 age or older.
