AN ACT

- Amending the act of February 14, 2008 (P.L.6, No.3), entitled 1 "An act providing for access to public information, for a 2 designated open-records officer in each Commonwealth agency, local agency, judicial agency and legislative agency, for procedure, for appeal of agency determination, for judicial review and for the Office of Open Records; imposing 5 6 penalties; providing for reporting by State-related 7 institutions; requiring the posting of certain State contract 9 information on the Internet; and making related repeals," further providing for definitions and for regulations and 10 policies. 11 12 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 13 14 Section 1. Section 102 of the act of February 14, 2008 15 (P.L.6, No.3), known as the Right-to-Know Law, is amended by 16 adding a definition to read: Section 102. Definitions. 17 The following words and phrases when used in this act shall 18 19 have the meanings given to them in this section unless the

- 1 <u>"Employee benefits."</u> Group life, health, hospitalization,
- 2 <u>medical service and accident insurance benefits, paid in whole</u>
- 3 or in part by an agency and offered generally to employees of
- 4 the agency. The term includes payments made in lieu of the
- 5 <u>specified benefits.</u>
- 6 * * *
- 7 Section 2. Section 504 of the act is amended to read:
- 8 Section 504. Regulations and policies.
- 9 (a) Authority. -- An agency may promulgate regulations and
- 10 policies necessary for the agency to implement this act. The
- 11 Office of Open Records may promulgate regulations relating to
- 12 appeals involving a Commonwealth agency or local agency.
- 13 (b) Posting. -- The following information shall be posted at
- 14 each agency and, if the agency maintains an Internet website, on
- 15 the agency's Internet website:
- 16 (1) Contact information for the open-records officer.
- 17 (2) Contact information for the Office of Open Records
- or other applicable appeals officer.
- 19 (3) A form which may be used to file a request.
- 20 (4) Regulations, policies and procedures of the agency
- 21 relating to this act.
- 22 (c) Local agency posting. --
- 23 (1) In addition to the information that is required to
- be posted under subsection (b), a local agency that maintains
- 25 <u>an Internet website shall post on its Internet website, for</u>
- 26 each employee of the agency:
- 27 <u>(i) The salary, wages or other compensation paid to</u>
- the employee.
- 29 <u>(ii) The cost of providing the employee with</u>
- 30 employee benefits. Cost information shall be segregated

- by the type of employee benefit provided.
- 2 (2) In the case of a local agency that does not maintain
- 3 an Internet website, the agency shall, at least once each
- 4 <u>calendar year, publish the information enumerated in</u>
- 5 paragraph (1) in a newspaper of general circulation or a
- 6 <u>newsletter or other document disseminated to all households</u>
- 7 within the jurisdiction of the agency.
- 8 Section 3. This act shall take effect in 60 days.
