## AN ACT

- Designating a bridge on that portion of State Route 3005 over the West Branch of the Susquehanna River, Greenwood Township,
- 3 Clearfield County, as the 1st Lieutenant Wendell Elbert Ross
- 4 Memorial Bridge.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Wendell Elbert Ross Memorial Bridge.
- 8 (a) Findings.--
- 9 (1) 1st Lieutenant Wendell Elbert Ross was born in
- 10 Lumber City, Pennsylvania, and bravely served in Company B,
- 11 141st Infantry Regiment, 36th Infantry Division of the United
- 12 States Army during World War II.
- 13 (2) While heroically serving his country, 1st Lieutenant
- 14 Ross was killed by sniper fire in Italy on February 11, 1944.
- 15 (b) Designation. -- The bridge located on State Route 3005 in

- 1 Greenwood Township, Clearfield County, over the West Branch of
- 2 the Susquehanna River is hereby designated the 1st Lieutenant
- 3 Wendell Elbert Ross Memorial Bridge.
- 4 (c) Signs.--The Department of Transportation shall erect and
- 5 maintain appropriate signs displaying the name of the bridge to
- 6 traffic in both directions on the bridge.
- 7 Section 2. Effective date.
- 8 This act shall take effect in 60 days.
