- 17 § 3302. Opt-out for abortion.
- 18 (a) Prohibition. -- The Commonwealth of Pennsylvania hereby
- 19 elects pursuant to the authority granted the states under
- 20 section 1303(a) of the Patient Protection and Affordable Care
- 21 Act (Public Law 111-148, 42 U.S.C. § 18023(a)) to prohibit
- 22 certain abortion coverage in qualified health plans offered
- 23 through the health insurance exchange under subsection (b).
- 24 (b) Included coverage prohibition. -- No qualified health plan
- 25 offered in this Commonwealth through the health insurance
- 26 exchange shall include coverage for the performance of any
- 27 <u>abortion unless the reason the abortion is performed is one for</u>
- 28 which the expenditure of public funds would be permitted under
- 29 18 Pa.C.S. § 3215(c) (relating to publicly owned facilities;
- 30 public officials and public funds).

- 1 (c) Excluded coverage prohibited. -- No qualified health plan
- 2 offered in this Commonwealth through a health insurance exchange
- 3 shall exclude coverage for:
- 4 (1) Treatment of any postabortion complication.
- 5 (2) Treatment of any miscarriage or any complication
- 6 <u>related to a miscarriage.</u>
- 7 (d) Option. -- Nothing in this section shall prohibit an
- 8 <u>individual from purchasing optional supplemental abortion</u>
- 9 coverage provided the individual pays a separate premium for the
- 10 coverage and obtains the coverage outside of the health
- 11 <u>insurance exchange</u>.
- 12 Section 3. This act shall take effect in 60 days.
