AN ACT

- 1 Amending the act of June 13, 1967 (P.L.31, No.21), entitled "An
- act to consolidate, editorially revise, and codify the public
- 3 welfare laws of the Commonwealth," in public assistance,
- further providing for prohibited use of public assistance
- 5 funds.
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. Section 484(a), (b) and (c) of the act of June
- 9 13, 1967 (P.L.31, No.21), known as the Human Services Code,
- 10 amended October 24, 2018 (P.L.777, No.125), are amended and the
- 11 section is amended by adding a subsection to read:
- 12 Section 484. Prohibited Use of Public Assistance Funds.--(a)
- 13 It shall be unlawful for any individual to:
- 14 (1) Purchase liquor or alcohol with an access device.
- 15 (2) Withdraw funds from an access device for any transaction
- 16 in a licensed facility or any retail establishment that provides
- 17 adult-oriented entertainment in which performers disrobe or
- 18 perform in an unclothed state for entertainment.

- 1 (3) Purchase tobacco or tobacco paraphernalia with an access
- 2 device.
- 3 (b) It shall be unlawful for a licensed gaming entity or an
- 4 entity licensed by the Pennsylvania Liquor Control Board to
- 5 allow for the withdrawal of funds from an access device or,
- 6 through a point-of-sale transaction, to allow the use of public
- 7 assistance benefits administered by the department.
- 8 (c) The Pennsylvania Gaming Control Board and the
- 9 Pennsylvania Liquor Control Board, in consultation with the
- 10 department, shall take appropriate measures to prevent the use
- 11 of public assistance funds for the purposes proscribed in this
- 12 section.
- 13 (c.1) Notwithstanding the prohibitions on the use of public
- 14 assistance funds in this section, this section shall not be
- 15 construed to apply to funds deposited onto an access device
- 16 which relate to child support or the State blind pension.

- 18 Section 2. This act shall take effect in 60 days.
