## AN ACT

- 1 Amending the act of June 13, 1967 (P.L.31, No.21), entitled "An
- act to consolidate, editorially revise, and codify the public
  - welfare laws of the Commonwealth," in public assistance,
- 4 further providing for prohibited use of public assistance
- 5 funds.

- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. Section 484(a) of the act of June 13, 1967
- 9 (P.L.31, No.21), known as the Human Services Code, amended
- 10 October 24, 2018 (P.L.777, No.125), is amended and the section
- 11 is amended by adding a subsection SUBSECTIONS to read:
- 12 Section 484. Prohibited Use of Public Assistance Funds.--(a)
- 13 It shall be unlawful for any individual to:
- 14 (1) Purchase liquor or alcohol with an access device.
- 15 (2) Withdraw funds from an access device for any transaction
- 16 in a licensed facility or any retail establishment that provides

- 1 adult-oriented entertainment in which performers disrobe or
- 2 perform in an unclothed state for entertainment.
- 3 (3) Purchase tobacco or tobacco paraphernalia with an access
- 4 device.
- 5 \* \* \*
- 6 (c.1) Notwithstanding the prohibitions on the use of public
- 7 <u>assistance funds in this section, this section shall not be</u>
- 8 construed to apply to funds deposited onto an access device
- 9 which relate to child support or the State blind pension.
- 10 (C.2) NO PENALTY SHALL BE ASSESSED AGAINST AN INDIVIDUAL, <--
- 11 AND THE DEPARTMENT MAY NOT DISQUALIFY AN INDIVIDUAL FROM
- 12 RECEIVING PUBLIC ASSISTANCE UNDER THIS SECTION, UNLESS THE
- 13 DEPARTMENT CLEARLY DEMONSTRATES THE FOLLOWING:
- 14 (1) THE SOURCE OF THE FUNDS WITHDRAWN FOR A PURPOSE
- 15 PROSCRIBED IN THIS SECTION IS PUBLIC ASSISTANCE.
- 16 (2) THE DEPARTMENT HAS INFORMED THE INDIVIDUAL ABOUT THE
- 17 PROVISIONS OF THIS SECTION.
- 18 (3) THE INDIVIDUAL HAS KNOWINGLY VIOLATED A PROVISION OF
- 19 THIS SECTION.

- 21 Section 2. This act shall take effect in 60 days.
