AN ACT

- 1 Amending Title 22 (Detectives and Private Police) of the
- 2 Pennsylvania Consolidated Statutes, in humane society police
- officers, further providing for appointment by nonprofit
- 4 corporations, for qualifications for appointment and for
- suspension, revocation, limitation and restriction of
- appointment and restoration of appointment.
- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 Section 1. Section 3704(a) of Title 22 of the Pennsylvania
- 10 Consolidated Statutes is amended and the section is amended by
- 11 adding a subsection to read:
- 12 § 3704. Appointment by nonprofit corporations.
- 13 (a) Application for appointment. -- A society or association
- 14 may apply to the court of common pleas in any county for the
- 15 appointment of an individual as a humane society police officer
- 16 for that county[.] by providing proof of qualification under
- 17 <u>section 3705 (relating to qualifications for appointment) to the</u>
- 18 court of common pleas and to the district attorney. The court,
- 19 upon [such application which includes proof of qualification
- 20 under section 3705 (relating to qualifications for appointment),

- 1 shall] reviewing the application and considering the
- 2 recommendation, if any, of the district attorney, may by order
- 3 appoint such person to be a humane society police officer.
- 4 (a.1) Review.--Upon receipt of an application for
- 5 appointment of an individual as a humane society police officer,
- 6 the district attorney shall conduct a background investigation
- 7 of the applicant and, within 60 days, provide input to the
- 8 court.

- 10 Section 2. Sections 3705 and 3706(a) of Title 22 are amended
- 11 to read:
- 12 § 3705. Qualifications for appointment.
- 13 [An individual shall be qualified for an] <u>In order for an</u>
- 14 <u>individual to be considered for</u> appointment as a humane society
- 15 police officer [provided] the society or association [submits]
- 16 <u>must submit</u> proof satisfactory to the court of common pleas <u>and</u>
- 17 the district attorney in each county for which the society or
- 18 association directs the individual to act as a humane society
- 19 police officer that the individual [meets all of the following
- 20 requirements]:
- 21 (1) Has been a resident of this Commonwealth for the
- 22 previous 12 months.
- 23 (2) Has successfully completed the training program
- established pursuant to section 3712 (relating to training
- program).
- 26 (3) Has obtained a criminal history report from the
- 27 Pennsylvania State Police pursuant to 18 Pa.C.S. Ch. 91
- 28 (relating to criminal history record information) or a
- 29 statement from the Pennsylvania State Police that the
- 30 Pennsylvania State Police central repository contains no

- 1 pertinent information relating to the individual who is the
- 2 subject of the application. The criminal history record
- 3 information shall be limited to that which may be
- disseminated pursuant to 18 Pa.C.S. § 9121(b)(2) (relating to
- 5 general regulations).
- 6 (4) Has not been convicted of an offense graded a felony
- 7 or a serious misdemeanor.
- 8 (5) Has not been convicted of any violation, including a
- 9 summary offense, of 18 Pa.C.S. § 5511 (relating to cruelty to
- 10 animals).
- 11 (6) Has not been convicted of an offense in another
- jurisdiction, state, territory or country in accordance with
- the laws of that jurisdiction, state, territory or country
- equivalent to an offense graded a felony or a serious
- misdemeanor or an offense of cruelty to animals.
- 16 § 3706. Suspension, revocation, limitation and restriction of
- appointment; restoration of appointment.
- 18 (a) Grounds for suspension, revocation, limitation or
- 19 restriction. -- By its own action, on petition by a district
- 20 attorney or pursuant to a written affidavit filed by a
- 21 complainant, the court of common pleas may, after conducting a
- 22 hearing, suspend, revoke, limit or restrict an appointment of an
- 23 individual to act as a humane society police officer in the
- 24 county if the court determines any of the following:
- 25 (1) Being convicted of a felony or a serious misdemeanor
- 26 in any Federal or State court or being convicted of the
- 27 equivalent of a felony in any foreign country, territory or
- 28 possession.
- 29 (2) Being convicted of an offense of cruelty to animals
- 30 in any Federal or State court or being convicted of the

- equivalent of a cruelty to animals offense in any foreign country, territory or possession.
- 3 (3) Presenting false credentials or documents or making 4 a false or misleading statement in the application for 5 appointment or a certification of completion of additional 6 training or submitting an application for appointment or a 7 certification for completion of additional training 8 containing a false or misleading statement.
- 9 (4) Carrying or possessing a firearm in the performance 10 of his or her duties without certification pursuant to 11 section 3711 (relating to limitation on possession of 12 firearms).
- 13 (5) The individual has conducted his or her authority to
 14 enforce animal cruelty laws in a manner that is substandard
 15 of conduct normally expected of humane society police
 16 officers.

- 18 Section 3. This act shall take effect in 60 days.
