AN ACT

Amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in miscellaneous provisions, further providing for 2 the offenses of homicide by vehicle while driving under 3 influence and for aggravated assault by vehicle while driving 4 under the influence. 5 6 The General Assembly of the Commonwealth of Pennsylvania 7 hereby enacts as follows: Section 1. Sections 3735(a)(1) and 3735.1(a) of Title 75 of 8 the Pennsylvania Consolidated Statutes, amended or added October 9 10 24, 2018 (P.L.925, No.153), are amended to read: § 3735. Homicide by vehicle while driving under influence. 11 (a) Offense defined. --12 13 A person who unintentionally causes the death of another person as the result of a violation of section 3802 14 15 (relating to driving under influence of alcohol or controlled 16 substance) and who is convicted of violating section 3802: 17 is guilty of a felony of the second degree; or 18 is quilty of a felony of the first degree if, before sentencing on the present violation, the person 19

- 1 has incurred a conviction, adjudication of delinquency,
- juvenile consent decree, acceptance of Accelerated
- Rehabilitative Disposition or other form of preliminary
- 4 disposition for any of the following:
- 5 (A) An offense under section 3802.
- 6 (B) An offense under former section 3731
- 7 (relating to driving under influence of alcohol or
- 8 controlled substance).
- 9 (C) An offense which constitutes a felony under
- 10 this subchapter.
- 11 (D) An offense substantially similar to an
- offense under clause (A), (B) or (C) in another
- jurisdiction.
- 14 (E) Any combination of the offenses under clause
- 15 (A), (B), (C) or (D).
- 16 <u>(iii) is guilty of a misdemeanor of the second</u>
- degree when the violation is not the cause of death, and
- 18 the sentencing court shall impose a fine of not more than
- \$5,000.

- 21 § 3735.1. Aggravated assault by vehicle while driving under the
- influence.
- 23 (a) Offense defined. -- Any person who negligently causes
- 24 serious bodily injury to another person as the result of a
- 25 violation of section 3802 (relating to driving under influence
- 26 of alcohol or controlled substance) and who is convicted of
- 27 violating section 3802 commits [a]:
- (1) A felony of the second degree when the violation is
- 29 the cause of the injury.
- 30 (2) A misdemeanor of the second degree when the

- 1 <u>violation is not the cause of the injury and the sentencing</u>
- 2 <u>court shall impose a fine of not more than \$2,500.</u>
