Sections 2720(b) and 2720.3 of Title 8 of the 8 Pennsylvania Consolidated Statutes are amended to read: 10 § 2720. Care, custody and control. * * * 11 12 (b) Planting, transplanting or removal. --13 (1) Council may, by ordinance, and with or without the 14 petition of a majority of the property owners, upon any 15 public street in the borough, plant, transplant or remove 16 shade trees. Council may, with or without petition, require 17 the planting and replanting of suitable shade trees along and

upon the sides of the streets, upon alignment and at points

as may be designated by ordinance, by the owners of property

1	abutting the street at the points designated. Any ordinance,
2	rule or regulation enacted under this chapter may establish
3	or reference an inventory of existing shade trees in the
4	borough and a list of shade tree species suitable for
5	planting or transplanting.
6	(2) Before the enactment of any ordinance requiring the
7	planting, replanting, transplant or removal of shade trees,
8	council may consider the following factors:
9	(i) The effect the action proposed by the ordinance,
0	or maintenance related to the ordinance, may have on the
1	environment.
_2	(ii) The long-term effects and short-term effects
.3	the ordinance may have on public and private property,
4	including the benefits provided to property, the
_5	replacement and maintenance costs for private and public

_7	rights-of-way or service.
8 ـ	(iii) The effect the action proposed by the
9	ordinance may have on pedestrian and traffic safety,
20	including impairment of any clear sighting at
21	intersections and other rights-of-way.
22	§ 2720.3. Notice of work.
23	If council proposes to plant, transplant or remove shade
24	trees on any street, notice of the time and place of the meeting
25	at which the work is to be considered shall be given in one
26	newspaper of general circulation once a week for two weeks
27	immediately preceding the time of the meeting. The notice shall
28	specify in detail the streets or portions upon which trees are
29	proposed to be planted, transplanted or removed. In the event
30	that a shade tree commission is to undertake the work, the

- 1 commission shall provide the notice. <u>During the meeting at which</u>
- 2 the work is to be considered, council or the commission shall
- 3 address the factors set forth in section 2720(b)(2) (relating to
